

## **KIRKLEES COUNCIL**

### **(Off Street Parking Places) (No. 1) Order 2022**

The Council of the Borough of Kirklees (hereinafter referred to as “the Council”) in exercise of their powers under Sections 32, 33 and 35 of the Road Traffic Regulation Act 1984 (hereinafter referred to as “the 1984 Act”), Part 6 of the Traffic Management Act 2004 and the Road Traffic (Permitted Parking Area and Special Parking Area) (Metropolitan Borough of Kirklees) Order 2006, together with all other enabling powers hereby makes the following Order:-

#### **PART 1**

##### **1. COMMENCEMENT AND CITATION AND INTERPRETATION**

This Order shall come into operation on the 27<sup>th</sup> day of May 2022 and may be cited as the “Kirklees Council (Off-Street Parking Places) (No. 1) Order 2022”.

In this Order the reference to “rail user” means any person who is legitimately using the railway service or who is awaiting someone who is legitimately using the railway service.

#### **PART 2**

##### **2. AMENDMENTS TO AN EXISTING ORDER**

The Kirklees Metropolitan Council (Off Street Parking Places) Order 2004 (as amended) but in particular amended by the Kirklees Council (Off Street Parking Places) (No 1) Order 2008 is hereby further amended by the insertion of the item referred to in the Schedule to this Order to replace item 67 of the First Schedule to the above mentioned 2004 Order as amended by item 31 of the First Schedule to the above mentioned 2008 Order.
