

**KIRKLEES COUNCIL  
(TRAFFIC REGULATION) (No. 28) ORDER 2022**

**VARIOUS ROADS IN THE HOLMFIRTH AREA**

The Council of the Borough of Kirklees propose to make the above Order under their powers in the Road Traffic Regulation Act 1984 the effect of which, as it affects lengths of road in Holmfirth in the Kirklees district, will be as follows:-

**1. To prohibit the waiting of vehicles at any time on the following lengths of road:**

i. Hollowgate, Holmfirth

- a) North-west side from a point 24 metres east of a point in line with the western building line of 29 Hollowgate to the extended boundary of Nos. 3/5 Hollowgate
- b) South-east side from a point 1.5 metres north-east of the boundary of Nos. 1/2 & 3/4 Hollowgate south-westwards to the junction of New Fold

ii. Huddersfield Road, Holmfirth

- a) South-east side from Victoria Street for a distance of 15 metres north-eastwards
- b) South-east side from its junction with Victoria Street south-westwards to a point 32 metres north-east of its junction with Hollowgate.

iii. Lower Mill Lane, Holmfirth

South-east side from its junction with Hollowgate for a distance of 41 metres in a south-westerly direction

iv. Town Gate, Holmfirth

East side from the junction of Dunford Road for a distance of 13 metres north-eastwards

v. Victoria Street, Holmfirth

- a) South-west side from a point 2.0 metres south-east of the boundary of Nos. 21 & 23 Victoria Street to its junction with Huddersfield Road.

**2. To prohibit the waiting and loading and unloading of vehicles at any time on the following lengths of road:-**

Victoria Street, Holmfirth

North-east side from its junction with Huddersfield Road south-eastward for a distance of 20.5 metres

**3. To prohibit the waiting of vehicles from 8am – 6pm, Monday to Sunday on the following lengths road:-**

i. Dunford Road, Holmfirth

South-west side from a point 4 metres north-west of a point in line with the south-eastern building line of No. 22 Dunford Road to a point 8.5 metres south-east of its junction with Victoria Square

ii. Hollowgate, Holmfirth

South-east side from the junction of New Fold to its junction with Lower Mill Lane.

iii. Huddersfield Road, Holmfirth

- a) North-west side from a point 8.0 metres north-east of its junction with Cooper Lane for a distance of 20.0 metres north-eastwards
- b) South-east side from a point 32 metres north-east of its junction with Hollowgate to a point 14 metres north-east of that junction

4. **To prohibit the waiting of vehicles from 8pm – 2am, Sunday to Sunday on the following length road:-**

Towngate, Holmfirth

East side from a point 13 metres north-east of its junction with Dunford Road for a distance of 24.5 metres in a north-easterly direction

5. **To prohibit the waiting and loading and unloading of vehicles between the hours of 7am – 10am and 4pm – 7pm, Monday to Friday on the following lengths of road:-**

i. Dunford Road, Holmfirth

South-west side from the junction of Victoria Square for a distance of 8.5 metres south-eastwards

ii. Hollowgate, Holmfirth

- a) North-west side from the extended boundary of Nos. 3/5 Hollowgate to its junction with Victoria Street.
- b) South-east side from the junction of Rotcher Road for a distance of 45 metres in a south-westerly direction
- c) Victoria Square, Holmfirth

South-east side from its junction with Dunford Road to the junction of Rotcher Road,

d) Victoria Street, Holmfirth

South-west side from its junction with Hollowgate for a distance of 52 metres in a north-westerly direction

6. **To limit the waiting of vehicles to 20 minutes with no return within 40 minutes on the following length of road (The restriction will apply from 8am to 6pm Monday to Saturday):-**

Huddersfield Road, Holmfirth

North-west side from a point 4 metres south-west of its junction with Hightown Lane for a distance of 19.5 metres in a south-westerly direction.

7. **To create a loading bay which will operate from 2am to 8pm on all days (with waiting limited to a period of 40 minutes, with no return within 1 hour) on the following length of road:-**

Victoria Street, Holmfirth

North-east side from a point 20.5 metres south-east of its junction with Huddersfield Road for a distance of 25.5 metres south-eastwards.

8. **To create a disabled parking bay which will operate at all times (with parking limited to a period of 3 hours with no return within 1 hour) on the following length of road:-**

Victoria Street, Holmfirth

North-east side from a point 46 metres south-east of its junction with Huddersfield Road for a distance of 14.0 metres south-eastwards

9. **To revoke certain items in the Kirklees Council (Traffic Regulation) (Holme Valley Area) (Consolidation) Order 2017 which will be redundant when certain of the restrictions referred to above are introduced**
