

**KIRKLEES COUNCIL  
(TRAFFIC REGULATION) (NO. 08) ORDER 2023  
VARIOUS ROADS IN HADE EDGE, HOLMFIRTH**

The Council of the Borough of Kirklees has made the above Order under their powers in the Road Traffic Regulation Act 1984 the effect of which, as it affects lengths of road in the Holmfirth area of the Kirklees district, will be to:

**Prohibit the waiting at any time on the following lengths of road:-**

1. Bayfield Close, Hade Edge, Holmfirth

Both sides from its junction with Dunford Road for a distance of 10 metres in an easterly direction

2. Bent Lane, Hade Edge, Holmfirth

Both sides from its junction with Dunford Road for a distance of 25 metres in a westerly direction

3. Dunford Road, Hade Edge, Holmfirth

- a) East side from its junction with Hill Top View for a distance of 11 metres in a southerly direction
- b) East side from its north-eastern junction with Greave Road for a distance of 13 metres in a northerly direction
- c) East side from its south-eastern junction with Greave Road for a distance of 19 metres in a southerly direction
- d) East side from a point 27 metres north of the projected northern kerb line of Green Abbey southwards for a distance of 100 metres
- e) East side from its junction with Bayfield Close for a distance of 11 metres in a southerly direction
- f) East side from its junction with Bayfield Close for a distance of 10 metres in a northerly direction
- g) East side from its junction with Penistone Road to its junction with Hill Top View
- h) West side from its junction with Penistone Road to its junction with Bent Lane
- i) West side from its junction with Bent Lane for a distance of 82 metres in a southerly direction
- j) West side from its north-western junction with Greave Road for a distance of 16 metres in a northerly direction

- k) West side from its south-western junction with Greave Road for a distance of 16 metres in a southerly direction
- l) West side from its junction with Green Abbey for a distance of 69 metres in a southerly direction
- m) West side from its junction with Green Abbey for a distance of 11 metres in a northerly direction

4. Greave Road, Hade Edge, Holmfirth

- a) North side from its north-eastern junction with Dunford Road for a distance of 14 metres in a north-easterly direction
- b) North side from its north -western junction with Dunford Road for a distance of 10 metres in a westerly direction
- c) South side from a point 70 metres south-west of its south-western junction with Dunford Road for a distance of 33 metres in a south-westerly direction
- d) South side from its south-western junction with Dunford Road for a distance of 9 metres in a south-westerly direction
- e) South-east side from its south-eastern junction with Dunford Road for a distance of 13 metres in a north-easterly direction

5. Green Abbey, Hade Edge, Holmfirth

Both sides from its junction with Dunford Road for a distance of 7 metres in a westerly direction

6. Hill Top View, Hade Edge, Holmfirth

Both sides from its junction with Dunford Road for a distance of 7 metres in an easterly direction

This Order was made on 14 November 2023 and will take effect on 27 November 2023.
