## **Application to Transfer a Private Hire/Hackney Carriage Vehicle & Licence**

In order to apply to transfer your plate and vehicle from one person to another you must ensure you have all the relevant documents before attending the office.

1. We require a letter or email of authorisation from the previous owner detailing the sale of the vehicle to the new proprietor.
2. Fee (Card) – Fee sheet can be found at [www.kirklees.gov.uk/licensing](http://www.kirklees.gov.uk/licensing)
3. Certificate of Insurance/Cover Note (must be in the new owners name)
4. Log Book or V5 Certificate (if full log book cannot be produced)
5. Operator letter confirming employment

**Please note:** The documents listed need to be produced at the appointment, as well as the application form completed. Failure to provide this information may result in you not being able to transfer the licence.
