Please accept the emails and attachments sent to you on the 23rd and 25th of May 2018 as part of this submission, to be laconic as requested.

The mains points of this submission are in connection with the development of sites H2684a and H2730a aiming to; Firstly, provide further details of effected heritage asset within the Woodsome valley; secondly to highlight the amenity and communal value of the Woodsome valley and hall; then finally to address the ineffective community consultation on the aforementioned sites.

Heritage considerations within Woodsome valley

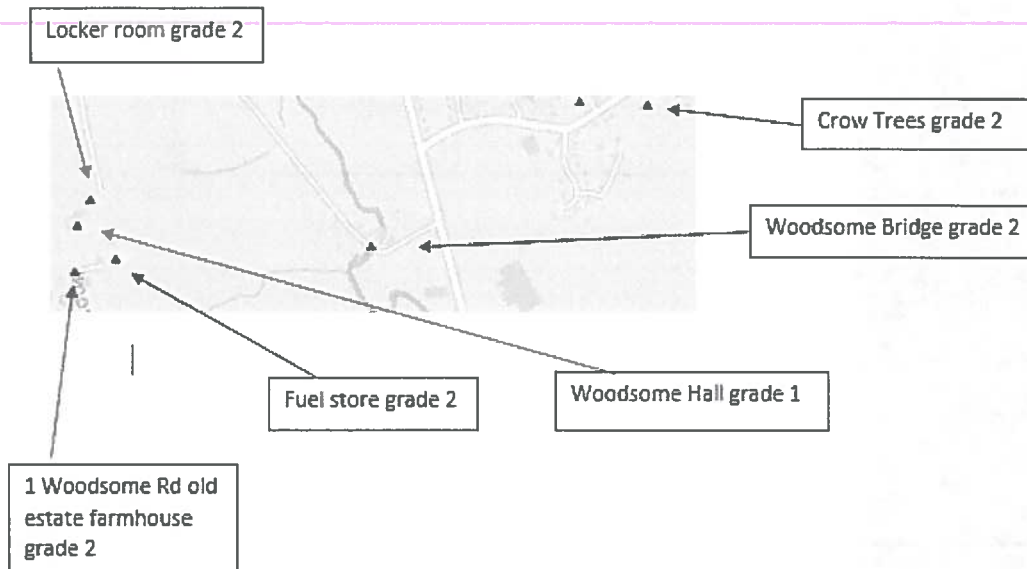


Figure 1. Historic England map of Heritage assets within Woodsome valley / 'old' Woodsome estate.

1.1 Woodsome Hall

Woodsome hall- Grade 1 listed "extremely fine hall house; The main range containing the hall faces east, and overlooks the terrace". C16 and the mid C17- Historic England List Entry Number: 1184158.

This building is spectacular, it looks out over its capability brown terrace and then a tree lined view over Woodsome valley ending at Lepton (ancient) great woods. As such, the 'Woodsome valley' view is of high significance and an important element of this building. The hall was obviously placed in its topographical position to take full advantage of the beautiful valley view to the end of the 'old' Woodsome estate, Lepton Woods. The view is equally as good in reverse, over the Woodsome valley, which H2684a and H2730a form an integral and substantial part (fig,2), to this grand hall. The loss of the valley to housing would be devastating for the hall and terrace, having an irreversibly damaging effect within this outstandingly beautiful valley. The hall is well maintained and open to members of the public daily having a restaurant, bar facilities and as a golfing and occasions venue. Having visited the hall for restoration purposes (I am not a golfer) due to the connection between my own listed building (Crow trees) and the hall, I was generously offered a guided tour. The hall, surroundings and views of the valley together are truly mythical, highly meriting the grade 1 listing. No HIA produced by council

1.2 Other heritage considerations

Woodsome old estate- Woodsome hall and one other hall house on the 'old estate' will be affected by the development of H2684a and H2730a in the Woodsome valley (Woodsome hall and Crow Trees old hall- appendix 1a)

Locker room- building immediately to the north of Woodsome hall- Historic England List Entry Number: 1313336 see appendix. No HIA produced by the council.

Crow Trees- cross wing of what was once a much larger house. - Historic England List Entry Number: 1135342. The HIA (LE98) on this listed building is inaccurate and in some places misleading (photographs/statements). HIA does not take into account the prominence of this building to the old estate and relationship to the Woodsome valley.

Woodsome Bridge- Early 19th century bridge- List Entry Number: 1135320

Details of this bridge and effect on it due to suggested infrastructure changes have been detailed in my matter 30 hearing statement (pp, 18-20). No HIA produced by the council.

Fuel store – Circa 15th century - List Entry Number: 1135321- *appendix 1b*

no HIA produced.

1 Woodsome Rd- late 18th early 19th century farmhouse- List Entry Number: List entry Number: 1184154- *appendix 1c-* no HIA produced

Mismanagement, bad planning decisions and lack of enforcement are affecting the Lepton area and wider community's heritage assets. These assets are slowly disappearing under a total lack of council sensibility towards the assets and public perspectives. How the local plan is orientated regarding Heritage assets at planning stage will most certainly hold creative adaptations.

2. Capability Brown- Historical connection between Woodsome Hall, Woodsome Valley (which includes H2684a and H2730a) and Lepton Woods.

Having highlighted the connection between Woodsome hall, the Capability Brown terrace and the value of Woodsome valley / H2684a and H2730a within my email and attachment (ID26) to you of 23rd May 2018, I will not repeat myself on this matter.

However, it should be noted that Brown was extremely active within the area of Lepton/ Fenay Bridge remodelling the estate of the Whitley Beaumont's in 1779 (*appendix2a*), Lepton great woods was part of the estate. He had worked on both estates that connected at the woods (*appendix 2b*) with the wall surrounding the wood and Woodsome bridge being rebuilt around this time. I understand that the work of Brown on the old Whitley Beaumont estate is also under threat within this local plan due to waste safeguarding and mineral extraction.

3. Leisure and tourism- amenity and communal value of the Woodsome Valley and Woodsome Hall.

3.1 Woodsome hall golf club

The Woodsome valley (H2684a and H2730a) is an integrative part of the enjoyment of the golf course (see *appendix 3a-d*) and club house/ Woodsome Hall, which has amenity and communal value for both the local and wider community at this leisure (golf) and tourism (restaurant/bar/hotel) site. Rather than attempting to explain the value of amenity that the Woodsome valley has for the golfing and non-golfing community using the facilities at Woodsome hall, they can explain themselves, *appendix 4a* holds a list of public reviews/ comments and photos taken by visitors showing a wider community appreciation of the Woodsome valley views (inc.H2684a and H2730a) and hall.

*The house itself is fascinating, and a perfect example of its type both inside and out. Perhaps its **highlight outside is the wonderful view from the stone balustrade overlooking what is arguably the most beautiful first tee in the country**- Woodsome Hall golf club website.*

3.2 Lepton (ancient) Great Wood.

As noted within my email to you of 25th May 2018 and attachment of the same date, detailing community responses (ID26), these comments give a reasonable general overview of the amenity value of the Woodsome valley for local people. However, I would also refer you to my matter 30 hearing statement (M30.25, pp3-7) which highlights the extent and level of community use of sites H2684a and H2730a for leisure purposes, this gives a context to the amenity and communal value of the Woodsome valley and sites H2684a and H2730a as part of that. The views over Woodsome valley to the hall mean so much to local resident, it is the view of 'home'.

4. Ineffective Community consultation (H2684a & H2670a).

In my opinion, the draft community consultations that took place on sites H2684a and H2730a are unreliable, which is highlighted within the oversight of important community concerns such as Woodsome valley (detailed in ID26). Whilst I acknowledge that the consultation scope was wide and most accessible method possibly utilised for collection, the analysis and interpretation/ reporting is evidently less than desirable.

Although it is difficult to comment due to the lack of transparency about the design and methodology utilised in assessing and interpreting community comments. It would seem that the council have picked what issues to report on, responding then in a predetermined fashion. This was not a question and answer session but a gathering of information to formulate a collective public option about main issues on sites. It is unethical to make assumptions regarding the importance of issues within such a consultation and not to take into consideration all data collected, which then ultimately shapes the outcome. In my understanding the local plan public consultations are not undertaken as a closed ended enquiry, thus the opportunity for the public to comment openly is provided, enabling the community to 'have a say'. Whilst I appreciate that not all issues raised on sites H2684a and H2730a are of value to the local plan, perhaps a textual thematic (collective) approach to analysis, would have enabled clearer collective reporting on main issues dealing with outliers appropriately. Nevertheless, the community of Lepton/ Fenay Bridge have taken time and effort to complete what some found a laborious task, in supplying the council with their story of reasoning on the sites, it is such a shame that their comments have been decimated and value defaced.

In conclusion, it is hoped that the details outlined provide a clear picture of the fundamental elements bringing together community's, Lepton great woods, Woodsome valley and hall. The outlined elements are rudimentary in terms of planning terminology and planning policy, but that link I shall leave to the professionals within the planning field to make.

In 1779 Lancelot 'Capability' Brown drew up a plan for remodelling the estate at Whitley Beaumont for owner Richard Henry Beaumont.

Beaumont's father had already carried out work on the house and gardens at Whitley Beaumont near Huddersfield, West Yorkshire. By 1760 there were formal avenues, serpentine paths and a terrace walk. Brown's improvements included new plantations, thicker belts of trees, extending the park to the south and creating a new drive and entrance.

Brown's visit to Whitley Beaumont in 1779 is recorded in his account book ([see on RHS website](#)). A plan, which no longer exists, was sent in May 1780 for the usual fee of £52 and 10 shillings (£86,000 in 2016). Before that visit, surveyor William Crossley had been instructed by Beaumont to measure the land on the estate.

Beaumont's letters

Between 1780 and 1784 there was a lot of activity in the park, as Brown's ideas were being put into practice. Telford's nursery in York supplied trees for the new plantations. Letters written by Beaumont to his friend Christopher Sykes of Sledmere paint a lively picture of how the work was progressing.

In February 1783 Beaumont wrote that he was preparing the ground for planting and that Crossley was "marking out Mr Brown's Plan". The following month work was hampered by snow and frost so that Beaumont could only "level hills & dig up old Roads". At that time he also mentioned moving large beech trees to "compleat [sic] a part of Mr Brown's ornamental designs".

Following his work at Temple Newsam, Brown again chose to adapt rather than remove the formal avenues at Whitley Beaumont. Extra planting behind them created the effect of a thick belt of planting around the whole estate. This can be seen on the estate map of 1822. In 1783-84 the lodges at the end of the avenue were replaced with ones designed by Sykes.

A maturing landscape

By 1816 the effects of Brown's changes could be seen in the maturing landscape. Historian Thomas Dunham Whitaker appreciated the new design: "The park was surrounded by its last possessor with plantations, which at once contribute to shelter and render the place conspicuous as an object.

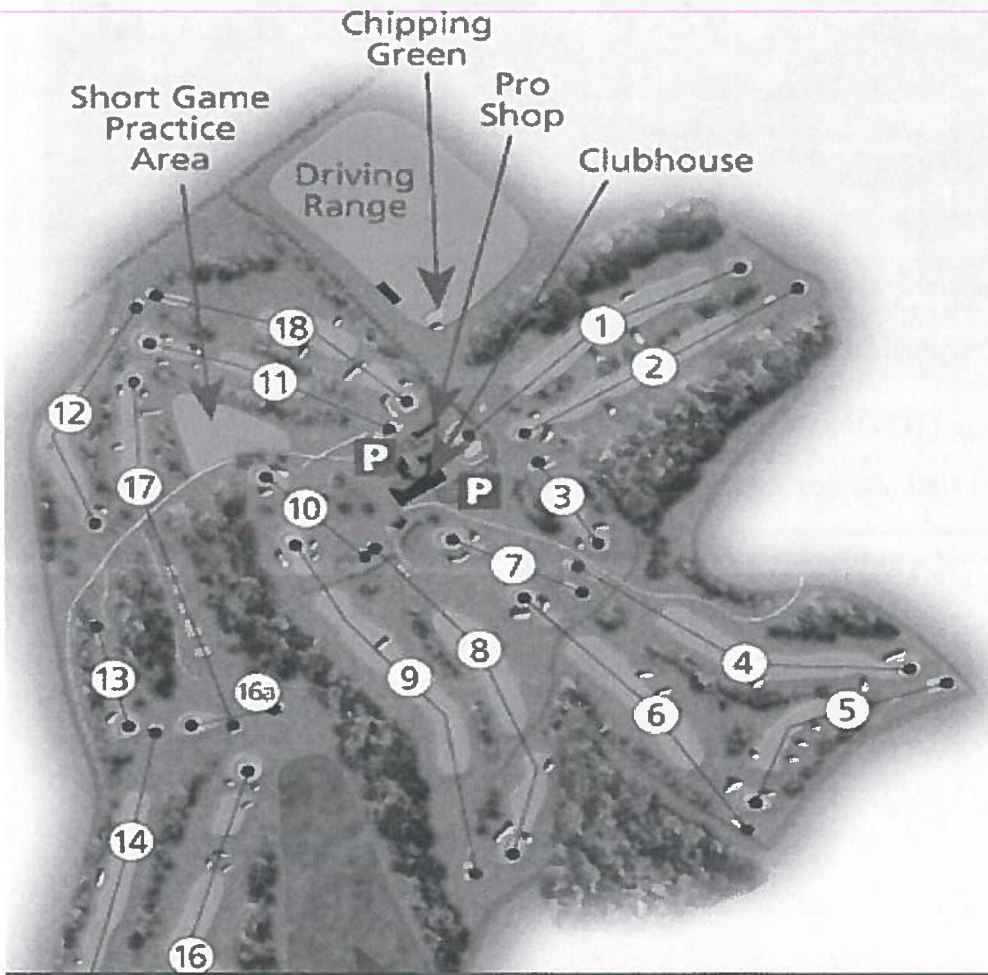

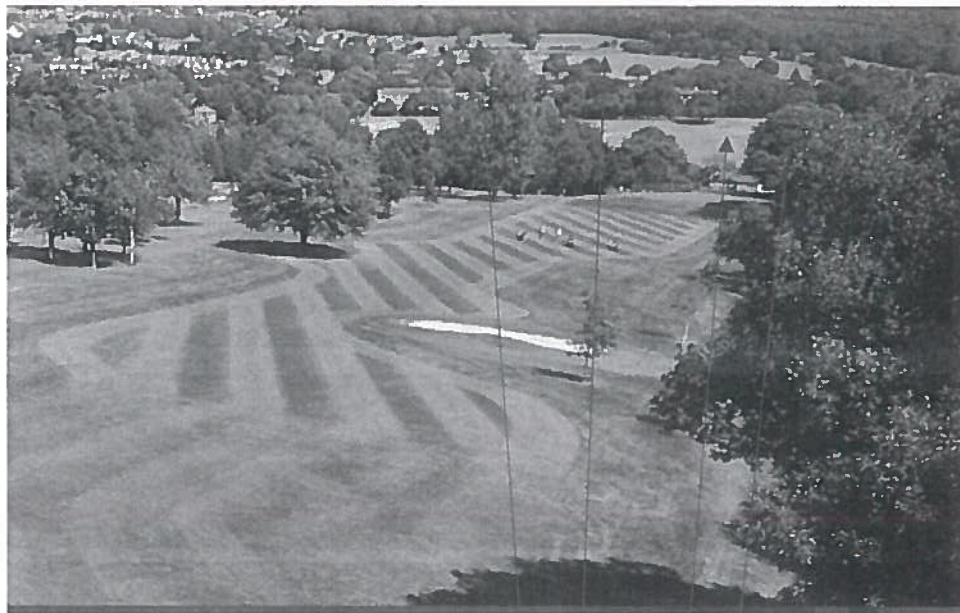
