

Holmfirth Conservation Group (HCG) is a community group set-up to undertake a conservation appraisal of Holmfirth, a conservation area without an appraisal which in 2009 was identified by English Heritage as a conservation area in 'At Risk and in decline'. No strategy has been put in place by Kirklees to reverse this trend.

HCG believes that the Kirklees Draft Local Plan does not set out 'a positive strategy for the conservation and enjoyment of the historic environment' as required by the National Planning Policy Framework (NPPF) – Historic Environment section 14 – 14.1 14.2

Within the Holme Valley only 2 of the 13 conservation areas have been appraised and in Kirklees as a whole only 21 of the 60 conservation areas have ever been appraised. Of the 4 conservation areas deemed at risk by English Heritage only 2 have ever been appraised.

Kirklees state in their Local Plan, section 14.20, 'The council will continue to produce appraisals and management plans...' and 'policies will be produced to guide the use and protection of heritage assets and local distinctiveness if appropriate.'

Kirklees has failed in its statutory duty, Planning (Listed Buildings and Conservation Areas) Act 1990. In the last 26 years it has only managed to appraise 1/3 of its conservation areas. We have been told by Kirklees, via email, with regard to our group undertaking a conservation area appraisal for Holmfirth that 'resources to take this further within the Council is limited. As such, we were urged to stress that the project cannot be guaranteed to be a priority'. Kirklees has also written to the Holme Valley Parish Council to state that it doesn't have the resources available to undertake conservation area appraisals. In these circumstances it is highly unlikely that Kirklees will meet either its heritage obligation as laid out in the NPPF or its commitments made in this Local Plan.

Policy PLR 3b states that Kirklees will 'ensure that proposals within Conservation Areas conserve those elements which have been identified as contributing to their significance in the relevant Conservation Area Appraisals; secure a sustainable future for heritage assets at risk and those associated with the local textile industry, historic farm buildings, places of worship and civic and institutional buildings....' Without conservation areas having been appraised this will not be feasible.

Historic England has expressed its wish to support local communities to undertake their own conservation appraisals but are unable to do so unless those groups have the support of their local planning authority. It is a shame that Kirklees appears unwilling to embrace the help being offered to allow it to fulfill its statutory duties.

In conclusion, it is with regret that we must ask for Kirklees' Local Plan to be rejected as it fails to meet the statutory requirements of the NPPF and in its current form its obligation to Heritage Assets is undeliverable.

I wish to update Holmfirth Conservation Group's (HCG) first response (18/12/2016) on the basis of a subsequent communication from Kirklees Council concerning HCG's production of a Conservation Area Appraisal (CAA) for the Holmfirth Conservation Area (HCA).

In order to support a change to the original submission (enclosed). I enclose a letter dated 03 May 2017 from, Paul Kemp, Service Director – Economy, Regeneration & Culture for Kirklees. In it he confirmed that the data and the subsequent CAA produced by HCG would be used to draw up and adopt a Conservation Area Management Plan for Holmfirth which would be formulated by Kirklees officers.

This letter opened the door to HCG to apply for funding from Historic England, who recognise the contribution community groups such as HCG can make to the process of appraising Conservation Areas (CAs). HCG has promised to share the resources it has used and the expertise it has gained in undertaking the survey and drafting the CAA, with other CAs nationally as it is acknowledged, by Historic England and others concerned with Conservation matters, that community involvement in the production of CAAs can help local authorities to carry out their statutory duties.

Whilst this letter from Kirklees provides the grounds to remove Holmfirth Conservation Area from the objection, it does not address the other unappraised Conservation Areas in Kirklees. To date there are 39 CAs in Kirklees without a Conservation Area Appraisal. Our substantive objection must, therefore, remain.
