Batley East, Batley West, Birstall & Birkenshaw
(TRAFFIC REGULATION) (NO. 12) ORDER 2017
Park Road, York Road, Lydgate Road, Mill Forest Way, Grange Valley Road, White Lee Road, Purlwell Lane, Branch Road, Batley and South Croft Avenue, Birkenshaw

The Council of the Borough of Kirklees has made the above Order under their powers in the Road Traffic Regulation Act 1984 the effect of which as it affects lengths of road in in the Kirklees district, will be as follows:-

- (i) to prohibit the waiting of vehicles at any time on the following lengths of road:
- Branch Road, Batley
 - a) South-west side from its junction with Henrietta Street for 15 metres north-westwards
 - b) South-west side and south east side from a point 23 metres south east of its junction with Henrietta Street to its junction with Commercial Street
 - c) South-west side from its junction with Henrietta Street for 23 metres south-eastwards
 - Grange Valley Road, Soothill, Batley
 - Both sides from its junction with Challenge Way to the extent of the adopted highway
 - Mill Forest Way, Soothill, Batley
 - Both sides from its junction with Challenge Way for a distance of 127 metres northwards
 - Sunny Bank Road, Batley, Upper Batley, Batley
 - North-west side from its junction with York Road for a distance of 10 metres north-eastwards
 - York Grove, Batley
 - Both sides from its junction with York Road for a distance of 10 metres north-eastwards
 - York Road, Batley
 - a) North-east side from its junction with York Grove to its junction with Sunny Bank Road
 - b) North-east side from its junction with Batley Field Hill for a distance of 10 metres south- eastwards
 - c) North-east side from its junction with York Grove for a distance of 10 metres north-westwards
 - d) South-west side from its junction with Batley Field Hill for a distance of 88 metres south-eastwards
- (ii) to prohibit the waiting of vehicles Mon-Fri 8am-9.30am & 2.30pm – 4pm on Lydgate Road, Batley on its north-east side from a point 11 metres south east of its junction with Soothill Lane to a point in line with the extended south eastern property border of No. 18 Lydgate Road
- (iii) to prohibit the waiting of vehicles Mon-Sat 7am-6.30pm on Park Road Batley on its north-west side from its junction with Bradford Road for a distance of 10 metres in a north-easterly direction

- (iv) to remove a legal order for school keep clear markings where the markings have already been removed on White Lee Road, Batley administrative correction only. No on street changes
- (iv) to prohibit loading and unloading Mon- Friday 8am-9.30am and 3pm -4pm on entrance markings on South Croft Avenue, Birkenshaw on its south east side from a point 73 metres south-west of the extended south-western kerbline of South Croft Drive for a distance of 31 metres south-westwards
- (vi) to introduce parking place residents permit holders on Purlwell Lane Batley on its south east side from a point 20 metres south west of its junction with Great Wood Street for a distance of 27.5 metres south westwards for residents of house numbers 25 27 29 and 31
- (vii) to revoke items in the Kirklees Council (Traffic Regulation) (Batley Area) (Consolidation) Order 2012 which will be redundant if the above cited proposals take effect.

This order will take effect on 31st August 2018

If any person wishes to question the validity of the Order, or any of its provisions, on the grounds that it, or they, are not within the powers conferred by the Road Traffic Regulation Act 1984, as amended, or that any requirement of the Act, or of any instrument made under the Act, has not been complied with, that person may within 6 weeks from the date on which the Order was made (i.e. by 15th October 2018) apply for the purpose to the High Court quoting reference DEV/JE/D116-1712.
