Cleckheaton (Traffic Regulation) (No18) Order 2016

Brunswick Street, Walkley Lane, Church Street, HECKMONDWIKE Pyenot Avenue,
Centurion Way, Whitechapel Road, CLECKHEATON, School Street,
NORRISTHORPE Quarry Road GOMERSAL

The Council of the Borough of Kirklees has made the above Order under their powers in the Road Traffic Regulation Act 1984 the effect of which as it affects lengths of road in the Kirklees district, will be as follows:-

(A) to prohibit the waiting of vehicles at any time on the following lengths of road:

Cleckheaton | a) North-east side from a point 35 metres north-east of its south-east terminal point for a distance of 47 metres in a north-westerly then north-easterly direction

b) South-west side from a point 43 metres north-east of its south-east terminal point for a distance of 63 metres in a north-westerly then north-easterly direction |
| 3. Pyenot Avenue,
Cleckheaton, | North-west side from a point 12 metres south-west of its junction with Pyenot Hall Lane for a distance of 61 metres in a south-westerly then southerly direction |
| 4. Walkley Lane,
Heckmondwike, | North-east side from its junction with Brunswick Street for a distance of 10 metres in a north-westerly direction |
| 5. Quarry Road,
Gomersal | West side from a point 65 metres south of the extended northern kerb line of Lower Lane for a distance of 50 metres in a southerly direction |

(B) to prohibit the waiting of vehicles Monday to Saturday 8am-6pm on the following lengths of road

- (C) to prohibit the waiting of vehicles Monday to Friday 8am-9.30am and 3pm-4pm on the following lengths of road

Liversedge | North-west side from a point 17 metres north-east of
its junction with Norrithorpe Lane for a distance of
77 metres north-eastwards |

- (D) to remove a legal order for school keep clear markings where the markings have already been removed on Whitechapel Road Cleckheaton. This is an administrative correction only. No on street changes
- (E) to implement a legal order for school keep clear markings on School Street Norrithorpe where the markings are on site already. This is an administrative correction only. No on street changes
- (F) to move the residents' parking bays for Permit Holders Only Monday to Saturday 8am-6pm on the north east side of Church Street Heckmondwike so they run from a point 10 metres south west of its junction with Thomas Street for a distance of 28 metres in a south-westerly direction
- (G) to revoke items in the Kirklees Council (Traffic Regulation) (Cleckheaton Area) (Consolidation) Order 2012 which will be redundant if the above cited proposals take effect.

The Order will take effect on 18th June 2018.

If any person wishes to question the validity of the Order, or any of its provisions, on the grounds that it, or they, are not within the powers conferred by the Road Traffic Regulation Act 1984, as amended, or that any requirement of the Act, or of any instrument made under the Act, has not been complied with, that person may within 6 weeks from the date on which the Order was made (i.e. by 25th June 2018) apply for the purpose to the High Court.
