

KIRKLEES COUNCIL (TRAFFIC REGULATION) (NO. 9) (EXPERIMENTAL) ORDER 2018

The Council of the Borough of Kirklees (“the Council”) in exercise of their powers under Sections 1, 2, 4 and 92 of the Road Traffic Regulation Act 1984 (“the Act”), and of all other enabling powers and after consultation with the Chief Officer of Police in accordance with Part III of Schedule 9 to the Act hereby make the following Order which relates to Ramsden Road, Holme Valley in the Kirklees District:-

PART I

1. Interpretation

- 1.1. Save where the context requires, any reference in this Order to a numbered Article is a reference to the numbered Article bearing that number in this Order.

PART II

2. No vehicular traffic

- 2.1. Save as provided in Article 2.2 no person shall, except upon the direction or with the permission of a police constable in uniform, cause or permit any vehicle to proceed in that length of road coloured red between the points marked A and B and shown on the plan in the Schedule to this Order.
- 2.2 Nothing in Article 2.1 shall apply to any vehicle of any adjacent landowner when exercising access to their land; any emergency services vehicle; or any Council maintenance vehicle when being used for that purpose

PART III

3. General

- 3.1. The restrictions imposed by this Order shall be in addition to and not in derogation of any restrictions or requirements imposed by any Regulations made or having effect as if made under the Act or by or under any other enactment.
- 3.2. Any reference in this Order to a Statute or Statutory Instrument shall include reference to any re-enactment or replacement thereof.
- 3.3. For the avoidance of doubt, any reference in this Order to a length of road shall be deemed to be a reference to more than one length of road or more than one parking place where the context requires it.
- 3.4 This Order or any provision within it may be modified or suspended by the Director of Place or other duly authorised officer of the Council if such modification or suspension complies with either Section 10.1 or Section 10.2 of the Act.

- 3.5 This Order shall come into operation on the 22nd day of November 2018 and may be cited as the "Kirklees Council (Traffic Regulation) (No. 9) (Experimental) Order 2018".
- 3.6 Unless continued in force by virtue of the provisions of Section 9(4) of the Act or modified or suspended in accordance with Article 3.4, this Order shall cease to have effect on the 19th day of May 2019.
