### 1.0 Engagement / Consultation

### **Engagement / Consultation to Date**

The scheme is included in the Council's Draft Local Plan and, as of writing is currently subject to an Examination in Public; the decision is not expected until late 2018.

To date, consultation and engagement with key stakeholders has taken place at several levels regarding the various transport schemes in the WY+TF.

### **Public Engagement Exercise**

An engagement exercise was undertaken from 5 March 2018 to 23 March 2018, with over 1200 letters being sent to local residents and businesses along the A62 corridor. The opinions of a wide range of stakeholders were sought which included:

- Elected members

- WYCA
- Bus operators
- Highways England

### Changes made as a result of engagement

Bus shelters will be incorporated to existing bus stops wherever footway width allows. These new bus shelters will also include real time information.

Also as a result of the comments received new access to the canal towpath will be investigated in terms of feasibility. Improved signage to the canal towpath will also be looked at. As well as this the canal towpath can potentially be resurfaced as part of the scheme, however, discussions with the Canals and Rivers Trust will need to take place in order to determine the next steps forward. Issues around the current surface of the footways were raised, as part of the scheme the footways will be resurfaced, addressing these issues. Another issue that was raised was around parking provision for residents, this will be investigated.

Comments were raised relating to the 'KEEP CLEAR' markings being ineffective currently and potentially need to be changed to yellow boxes, this will be included within the scheme. Yellow box markings will also be incorporated into the Red Doles Lane junction and it will investigated as to whether there are further junctions that require yellow box markings to be included in the scheme design.

### A62 Smart Corridor Phase 1 – Early Engagement

Kirklees Council welcomes your views on a plan to improve traffic flows on the existing A62 Leeds Road.

### Why are the improvements needed?

As you will know, the A62 Leeds Road is severely congested at peak traffic times. Average travel speeds are both unreliable and slow. If you are a regular user of the A62, you will no doubt be aware of the queuing traffic, delays at junctions and lack of facilities for pedestrians and cyclists.

#### What is proposed?

The A62 Leeds Road scheme is in the early development stage, but we are using the results of previous studies we have done at the junctions to create a concept design. We are currently considering a series of traffic improvements at the signalled junctions down Leeds Road. The main benefits of the scheme will be to:

- Reduce traffic and congestion;
- Reduce the potential for accidents;
- Improve air quality;
- Improve conditions for local residents and businesses;
- Improve conditions for cyclists and pedestrians;
- Improve bus reliability and services;
- Enable access to land for new housing and economic development.

Given that we knew we wanted to make improvements along the route over the next few years, the Council encouraged Northern Gas to do their network replacement works well before our roadworks would be implemented. However, not wanting to waste money we have talked to them about

incorporating some minor improvements into their re-instatement works at the Old Fieldhouse Lane junction, so that they are not replacing the signals, only for the Council to have to dig them up later.

### Who is promoting the scheme?

Early last year, Kirklees Council submitted an Expression of Interest for the A62 Leeds Road corridor, as this is one of our most heavily congested routes. The expression of interest was accepted and is now being looked at alongside a submission to the European Regional Development Fund for additional funding to incorporate Green Infrastructure into any improvements that are ultimately proposed.

This multi-million pound scheme is being promoted by Kirklees Council, as Local Highway Authority, but is supported and funded by the West Yorkshire Combined Authority. The Council has currently secured funding to investigate how we can improve things, but the detailed design will only be undertaken when we have considered feedback from users, businesses, and residents on Leeds Road. We are hopeful we can then develop a detailed scheme, secure the full funding from the West Yorkshire Combined Authority and start on site as early as 2019.

The funding will not come out of the Council's budget; therefore, this scheme will not have an impact on other Council services.

#### **Your chance to Have Your Say!**

We are now seeking opinions and thoughts from you as a local business owner, resident, or regular users of the A62 to help inform the development of a design.

Given the issues we know about in this area, the following measures may provide a solution:

- Improved junctions widening / narrowing, easing kerb lines to allow better access;
- Improved signals new technology;
- Relocation of existing bus stops, pedestrian crossings;
- Introduction of segregated cycle lanes (or shared cycle / footways, or on-road cycle provision; and
- Enhanced landscaping

# A62 Smart Corridor Phase 1 Frequently Asked Questions (FAQs)

### 1. What is the A62 Smart Corridor Phase 1 scheme?

The scheme is a package of measures, which seeks to address the causes of vehicle-based congestion along the A62 Leeds Road, thus reducing and making journey times more reliable. At the same time, the scheme will also look to improve facilities for residents, businesses, and users whilst also improving the Leeds Road environment.

### 2. Where is the scheme? Is it the full length of Leeds Road?

The scheme starts at the junction of Huddersfield Ring Road / Southgate / Northumberland Street and ends at the junction of A62 / Old Fieldhouse Lane; a corridor length of approximately 2.0km. Along this corridor are several key junctions, namely:

- Huddersfield Ring Road / Southgate / Northumberland Street;
- Leeds Road / Lower Fitzwilliam Street / Gasworks Street;
- Leeds Road / Thistle Street / Hillhouse Lane;
- Leeds Road / St Andrews Road;
- Leeds Road / Bradley Mills Road / Barr Street;
- Leeds Road / Bradley Mills Road / Red Doles Lane;
- Leeds Road / Old Fieldhouse Lane

### 3. Why do we need to do something?

The Council has a statutory duty under the Traffic Management Act to consider options that improve traffic flow. The A62 Leeds Road is one of the key routes into Huddersfield; it is a corridor with one of the largest movements of people in the Kirklees area by all modes and the least spare capacity to accommodate that movement. The existing road network is unable to cope at peak times, which is leading to significant delays and congestion. Compound the current issues with the projected natural growth and future development needs and it becomes evident that interventions are necessary to help existing traffic and allow for future growth.

#### 4. What will it involve?

At this stage, there has been no decision made on any details of the scheme, although given the constraints in the area and the land available, there is limited scope for major alterations e.g. a bypass or major road widening. Given the known challenges in the area and the impact that congestion is having on journey times etc. it is likely that the scheme will involve the following:

- Improvements to the signalled junctions;
- Improvements to kerb lines at junctions to ease movement;
- Improvements to pedestrian crossings;

- Improvements to cycle provision (either on or off highway);
- Improvements to bus provision
- Resurfacing, new lining and signing
- Inclusion of landscaping (Green Infrastructure) along the route

### 5. What will this achieve?

The principal aims of the scheme will be to:



- Reduce traffic and congestion;
- Reduce the potential for accidents and improve severance;
- Improve air quality;
- Improve conditions for local residents and businesses;
- Improve conditions for cyclists and pedestrians;
- Improve bus reliability and services; and
- Enable access to land for housing and employment developments

### 6. Who is paying for the scheme? Where is the money coming from?

The project is to be funded by the West Yorkshire Combined Authority (WYCA). Kirklees Council has to submit a business case to the WYCA for their approval for the scheme to proceed. If successful, we will receive the funding allocated to the scheme through the West Yorkshire plus Transport Fund.

We WILL NOT be using Council tax or other Council revenue streams, therefore, funding this scheme will not impact on other Council services.

### 7. What is the West Yorkshire Combined Authority (WYCA)?

The Combined Authority was formed in April 2014 to be the driving force for economic growth across the West Yorkshire and the City of York Council area. The West Yorkshire Combined Authority brings together key decision-making powers into a single body. To find out more visit: <a href="https://www.westyorks-ca.gov.uk">www.westyorks-ca.gov.uk</a>.

### 8. Can the money be spent on any other projects?

The A62 Leeds Road scheme has funding provisionally allocated earmarked from the West Yorkshire plus Transport Fund and therefore the funding will not able to be spent on any other proposals or scheme. If WYCA do not accept the scheme's business case, then the scheme cannot go ahead and the money earmarked for this project will be allocated elsewhere in the region; not necessarily in Kirklees.

### 9. When will you have the detailed design?

Following the consultation, feedback received will be considered and options for improvement will be apprised in accordance with guidelines approved by the Department for Transport (DfT). The current intention is to hold a public exhibition in late summer/early autumn 2018 to publicise a proposed scheme. The public exhibition is to seek further input into the preferred scheme and to illustrate the quantified benefits it

will deliver, and give residents another opportunity to comment on the design before it is finalised.

### 10. When will you start work on the improvements?

If we get approval, it is anticipated that work could commence on site as early as March 2019 with all works being completed by 2020.



### 11. Will my comments be considered?

The Council has secured initial funding to develop the business case and undertake transport modelling. Your comments will help inform a scheme which aims to address not only the underlying highway issues but also the needs of local residents, business owners, and commuters. By having your say and sharing your views we will be able to ensure that the priorities and thoughts you have on your area are reflected in any scheme design.

### 12. Who can take part? Can I tell other people to take part?

We welcome the opinions and feedback of anyone. Whether you travel by public transport, walk, drive or cycle, are a business owner or just travel through the area, your views and insight is valuable to us to shape our scheme. We will consider the feedback and a 'You Said We Did' report will be prepared and posted on-line to provide an opportunity to see which elements will be taken forward and incorporated into the scheme design or not. In the event we cannot incorporate your design, we will provide a response as to why.
