- You must trade within your allocated space and not encroach outside your designated space.
- You are required to have your own insurance liability for damage / theft of any of your equipment
- You are required to hold appropriate public and third party liability insurance to the satisfaction of the Council.
- You must follow any instructions issued by the Markets Manager or their representative
- You must use the stall or pitch only for the goods and services as agreed on the application form.
- You shall not sell or display any item that contravenes the Councils policies.
- Refunds for cancellations will be at the discretion of the Markets Manager or their representative.
- Only food products, which have been produced, grown, raised, baked or caught locally (within a radius of 40 miles of the market), will be accepted. Unusual or difficult to source produce may be accepted from outside the 40 mile radius.
- No genetically modified produce or goods containing genetically modified ingredients may be sold.
- Only the producer, his or her family or employee is permitted to sell the produce. Local growers' organisations on this occasion may appoint a representative to sell pooled produce.
- Stallholders should label items for sale with their name and place of business. Prices should be clearly displayed.
- Stallholders should maintain their stall spaces in clean and sanitary condition and shall remove all boxes, packaging and debris at the end of the day.
- Produce must be clearly labelled with the producers name and place of business in addition to legal labelling requirements
