



**Glenfield Avenue** 

Report on the findings from feedback received during a public engagement on the proposed changes to Glenfield Avenue play area, Ashbrow, Huddersfield.

*Kirklees Council Research and Consultation Team August 2022* 



- The Glenfield Avenue play area consultation took place from 16<sup>th</sup> May to 21<sup>st</sup> July 2022.
- The purpose of the consultation was to communicate the draft proposals for a new play area directly with the public and gather feedback.
- The methodology used was a short online survey.
- The survey involved sharing the draft plans and asking for views via several closed and open questions.
- Overall, 9 respondents completed the online survey.

## Headline Results


- Due to the **low response rate** caution is advised regarding any steps taken from these results.
- As some patterns are apparent, we can use the results as a **general indication** of the public response.
- The **majority of respondents (89%) agreed** to some extent with the proposals for the redesigned park with **11% not in full agreement.**
- The majority of respondents agreed with all key features of the proposed plan, with the steel junior climber receiving the highest level of disagreement (22%).



A summary of results for each question as it appeared in the survey is detailed below.


Please note percentages may not always total 100%, due to rounding.





The majority of respondents (89%) agreed to some extent with the proposals for the redesigned park (78% Yes / 11% Mostly) with 11% not in full agreement.

Would you agree with the proposal to remove the fence?




The majority of respondents (78%) agreed with the proposal to remove the fence.

Respondents were then asked to what extent they agreed with the 11 key features of the proposed plan:

The 3 features to receive the highest percentage of agreement were the proposed changes to the play area entrance (78% agreement), the small swale with boulders (78% agreement), and the steel 2 bay swings with toddler and flat seats (78% agreement).

The only 3 features to receive any level of disagreement were the chin-up bar (11% disagreement), the spinner (11% disagreement) and the steel junior climber (22% disagreement).

Respondents were then asked two open questions:

## This play area has been designed to cater for a wide range of ages and abilities. Do you have any suggestions for how the improvements can better meet local needs?

This was an open question and received 3 comments:

- The plan requires equipment suitable for disabled children.
- More equipment for babies is needed.
- Criticism of the chosen location of the play area.

## Please us the space below to provide any other comments about these proposals:

This was an open question and received 2 comments:

- Concerns over the air quality of the play area given its proximity to the A62.
- Extra bins and benches are needed.
