

## NON-COMMERCIAL SHARING LICENCE TO RE-USE DOCUMENTS

2. ## **RE-USE**

- 5. a)** In this Licence “re-use” means the following non-exclusive rights:

- c) after the period of 6 calendar months from the date of Re-use by the User when it shall then be renewable only in accordance with the terms of the Non-commercial Sharing Licence to use Documents applicable at the time of renewal.

## **GENERAL**

- 9.
