The Centre 27 Business Park, Birstall currently consists of 3,479 m2 of office space in 8 No. units.

This proposal is to convert Unit 4 into 4 No. residential units (please see accommodation schedule attached). This represents an increase of 4 No. residential units on the site.

There will be no impact on the current Highways situation.

There are currently approximately 11 No. parking spaces on site, providing a provision in excess of that required for residential use.

The site sits outside any flood risk areas.

Risk from contaminants is low. Please see attached DeltaSimons Report.

There is a cinema to the North East, restaurants to the East and North East, Offices to the South East and Open Fields to the South West. These are all located at an acceptable distance away, so there will be no impact from noise.
