The KIRKLEES COUNCIL hereby give notice that LISTED BUILDING CONSENT has been granted for the execution of the works referred to:-

LISTED BUILDING CONSENT FOR REPLACEMENT WINDOWS

At: 26, WEST VIEW, PADDOCK, HUDDERSFIELD, HD1 4TX

In accordance with the plan(s) and applications submitted to the Council on 23-Jan-2017 subject to the condition(s) specified hereunder:-

1. The development shall be begun not later than the expiration of three years beginning with the date on which permission is granted.

Reason: Pursuant to Section 18(1) of the Planning (Listed Buildings and Conservation Areas) Act 1990, as amended by the Planning and Compulsory Purchase Act 2004.

2. The development hereby permitted shall be carried out in complete accordance with the approved plans and specifications except as may be required by other conditions.

Reason: In the interests of visual amenity and to accord with National Planning Policy Framework Core Planning Principles (paragraph 17), Section 7 and Section 12.

3. All external joinery shall have a painted not stained finish. The colour of the painted finish shall match a colour from the Farrow and Ball Colour Range.

Reason: To ensure a traditional fenestration appearance and to sustain the significance of the heritage asset in accordance with National Planning Policy Framework Section 7 and Section 12.

4. Double glazing units installed within the approved replacement sliding sash windows shall be of a slim profile which shall be no thicker than 12mm and retained thereafter.

Reason: To ensure that sympathetically designed windows which preserve the architectural significance of the designated heritage asset are installed, in accordance with the National Planning Policy Framework, Section 12 (Conserving and enhancing the historic environment).

You must use the correct Planning Appeal Form when making your appeal. The Secretary of State has power to allow a longer period for the giving of a notice of appeal and he will exercise his power in cases where he is satisfied that the applicant has deferred the giving of notice because negotiations with the Local Authority in regard to the proposed works are in progress.

Please note, only the applicant possesses the right of appeal.
