Sycamore Tree (part of a W4 group of trees stretching several hundred metres across many gardens). Tree is located right in front of 100 year old drystone wall. Tree was protected 14 years ago, during which time it has grown to such a height that the root system has now dislodged and caused partial collapse of the drystone wall which forms the boundary between three properties. The base of the wall is retaining the land on which the tree grows, causing concern that the tree could collapse over the wall if it is allowed to continue growing. The tree trunk has also increased in girth to such a point that the trunk intersects the boundary line. Removal of the tree would still leave several mature trees in the garden (i.e. plenty of tree cover remains).

In addition to this tree, there is another Sycamore in a similar position further to the right of this tree and a similar distance away from another section of the wall. The concern is that this tree could also cause a similar collapse of the wall in the near future.

The site has been surveyed by Kieran of Tree Solutions, Huddersfield (07900 153 856) who agreed that the root systems of the trees are to blame for the collapse of the wall, and that they pose a risk to the remaining section of the wall (see attached photographs).

We cannot replant in place of these trees within the garden as the canopy is extremely crowded with 6 other trees already competing for light. The trees are too close to the wall.
