Kirklees Community Association are a local charity, focusing on the provision of affordable housing across Kirklees. We are in possession of a single storey, one bed under-dwelling adjacent to the large Co-op car park in the centre of Holmfirth. The property is approximately 28.8 sq mtrs in area, and due to both its size and location, has become increasingly difficult to let. With this in mind we now consider a change of use to be the most practical solution. We are seeking a change from C3 residential to B1 commercial, either office space or something along the lines of chiropodist or physiotherapist. Internal works will be restricted to the removal of an internal wall, making the main reception area & kitchen open plan and the conversion of the existing 3 piece bathroom to a slightly smaller shower room with WC and basin. The outside will remain unaltered.
