Myself and my husband are currently in the process of buying Elm Crest Guest House in Huddersfield. Following pre-application planning advice and the subsequent report from Kirklees (see attached) we are seeking planning permission to change the use from C1 to C3 and for this to come into effect from the date of completion. We are required to evidence the approved planning permission to our mortgage providers (who will grant us the mortgage on condition that the property will be classified as C3 use on the date of completion).

Notes

- In answering the planning application question we have found a number of questions to have a restricted choice of responses. This has meant for our type of planning application we have had to choose the most relevant response which wasn't as accurate response as we would wish to provide. We therefore apologise in advance if the response is not completely satisfactory.
- Related to point 1 above is the response we have provided to the section on 'Certificate of ownership'. As we are in the process of purchasing Elm Crest we are not yet the owners of the property. It is only possible for us to purchase Elm Crest once planning permission has been granted, as this can only be achieved once the mortgage company provide the mortgage. Hence 'The Date Noticed Served' in this context is the date the current proprietors accepted our offer. The proprietors are also aware that we are going through planning application for change of use from C1 to C3 and are supportive of this. Should it be required, we believe the current proprietors would be willing to provide any supporting statements.
- In relation to the site area we have provided approximations from the Land Registry Entry (attached).
