There are five trees on both sides of the northern boundary of All Saints' Church (area G4 on TPO No. 6 2011) Four of them are Limes with TPO's on them plus a fifth tree. On the plan they are marked XA and XE Limes in the Church Yard and XC and XD Limes in The Vicarage grounds and OB a tree of unknown type also in The Vicarage grounds. The five trees need Crown Thinning and Crown Reduction to prevent further damage to the fabric of the Church caused by falling debris and leaves. Trees XA, XB, XC and XD Crown Thinning and Crown Reduction 25% and tree XE Crown Thinning and Crown Reduction 30% the work to be carried out by a approved tree surgeon.
