PLANNING PERMISSION FOR DEVELOPMENT

Application Number: 2018/62/91576/E

In pursuance of its powers under the above-mentioned Act and Order the KIRKLEES COUNCIL (hereinafter called “The Council”) as Local Planning Authority hereby permits:-

ERECTION OF EXTENSIONS AND ALTERATIONS

At: 15, OLD MILL VIEW, THORNHILL LEES, DEWSBURY, WF12 9QJ

In accordance with the plan(s), documents and application submitted to the Council on 14-May-2018, except as amended or specified, details of which can be found in the table below and subject to the condition(s) specified hereunder:-

1. The development hereby permitted shall be begun within three years of the date of this permission.

Reason: Pursuant to the requirements of Section 91 of the Town and Country Planning Act 1990.

2. The development hereby permitted shall be carried out in complete accordance with the plans and specifications schedule listed in this decision notice, except as may be specified in the conditions attached to this permission, which shall in all cases take precedence.

Reason: For the avoidance of doubt as to what is being permitted and so as to ensure the satisfactory appearance of the development on completion, and to accord with Policies D2, BE1, BE13, NE9 and T10 of the Kirklees Unitary Development Plan, Policies PLP22, PLP24 and PLP33 of the Kirklees Publication Draft Local Plan as well as the aims of the National Planning Policy Framework.

3. The external walls and roofing materials of the extensions hereby approved shall in all respects match those used in the construction of the existing dwelling.

Reason: In the interests of visual amenity and to accord with Policies D2, BE1 and BE13 of the Kirklees Unitary Development Plan, Policy PLP24 of the Kirklees Publication Draft Local Plan and the aims of chapter 12 of the National Planning Policy Framework.

4. Notwithstanding the provisions of the Town and Country Planning General Permitted Development Order 2015 as amended (or any Order revoking or re-enacting that Order) no development included within Classes A-E of Part 1 of Schedule 2 to that Order shall be carried out without the prior written consent of the Local Planning Authority.

Reason: To ensure that unsatisfactory extensions do not result in overdevelopment of the site and to avoid potential for harm to be caused to the protected trees adjacent to the host property and to accord with Policies D2, BE1 and NE9 of the Kirklees Unitary Development Plan, Policies PLP24 and PLP33 of the Kirklees Publication Draft Local Plan as well as the aims of chapter 15 of the National Planning Policy Framework.

5. Notwithstanding the submitted plans and information, an Arboricultural Method Statement, in accordance with British BS 5837 and a Tree Protection Plan, shall be submitted and approved in writing by the Local Planning Authority before development commences. The method statement shall include details on how the construction work shall be undertaken with minimal damage to the adjacent protected trees and their roots. Thereafter, the development shall be carried out in complete accordance with the Arboricultural Method Statement.

Reason: So as to protect to viability of the protected mature trees within close proximity to the application site and to accord with Policy NE9 of the Kirklees Unitary Development Plan and Policy PLP33 of the Kirklees Publication Draft Local Plan. This is a pre-commencement condition in order to ensure that any measures to protect the mature trees are implemented at the relevant stage of the development.

6. The foundations of the extension hereby approved shall be completed in accordance with the details submitted on the submitted proposed foundation layout T- 7948 (Web ID 690861) and the supporting Grundomat Piling Mole Statement (Web ID 690860).

Reason: So as to protect the viability of the protected mature trees in the interests of visual amenity and to accord with the aims of Policy NE9 of the Kirklees Unitary Development Plan, Policy PLP33 of the Kirklees Publication Draft Local Plan and the aims of chapter 15 of the National Planning Policy Framework.

NOTE: Due to its location, a bat roost may be present on site. Bats are a European protected species under regulation 41 of the Conservation of Habitats and Species Regulations 2010. It is an offence for anyone intentionally to kill, injure or handle a bat, disturb a roosting bat, or sell or offer a bat for sale without a licence. It is also an offence to damage, destroy or obstruct access to any place used by bats for shelter, whether they are present or not.

If bats are discovered on site development shall cease and the applicant is advised to contact Natural England for advice.

Pursuant to article 35 (2) of the Town and Country Planning (Development Management Procedure) Order 2015 and guidance in the National Planning Policy Framework, the Local Planning Authority have, where possible, made a pre-application advice service available, complied with the Kirklees Development Management Charter 2015 and otherwise actively engaged with the applicant in dealing with the application.

Given the proximity to protected trees within the rear garden, there were significant concerns regarding the level of pruning which would have been likely to be required to facilitate the originally proposed increase in height of the dwelling and the substantial roofing over the rear extension which would have resulted in long term implications for the continued health and vitality of the protected tree. As such, the scale and massing of the scheme have been substantially reduced with the height of the host dwelling remaining at 8m as opposed to the originally proposed increase to 9.4m and the use of hipped roofs over the first floor rear extension as opposed to the originally proposed very large perpendicular pitched roof.

Building Regulations

Appeals to the Secretary of State

- If you are aggrieved by the decision of your Local Planning Authority to grant it subject to conditions, then you can appeal to the Secretary of State under section 78 of the Town and Country Planning Act 1990.
- As this is a decision for a householder application, if you want to appeal against your Local Planning Authority's decision to impose planning conditions then you must do so within 6 months of the date of this notice.
- If an enforcement notice is served or has been served relating to the same or substantially the same land and development as in your application and if you want to appeal against the local planning authority's decision on your application, then you must do so within 28 days of the date of service of the enforcement notice.
- Appeals must be made using a form which you can get from the Secretary of State at Temple Quay House, 2 The Square, Temple Quay, Bristol BS1 6PN (Tel: 0303 444 5000) or online at <https://www.gov.uk/planning-inspectorate>. - You must use the correct Planning Appeal Form when making your appeal. If requesting forms from the Planning Inspectorate, please state the type of application that the appeal relates to so they can send you the appeal form you require.
- The Secretary of State can allow a longer period for giving notice of an appeal, but he will not normally be prepared to use this power unless there are special circumstances which excuse the delay in giving notice of appeal.
- The Secretary of State need not consider an appeal if it seems to him that the local planning authority could not have granted planning permission for the proposed development or could not have granted it without the conditions they imposed, having regard to the statutory requirements, to the provisions of any development order and to any directions given under a development order.
- In practice, the Secretary of State does not refuse to consider appeals solely because the Local Planning Authority based their decision on a direction given by him.

Please note, only the applicant possesses the right of appeal.

Purchase Notices

- If either the local planning authority or the Secretary of State refuses permission to develop land or grants it subject to conditions, the owner may claim that the owner can neither put the land to a reasonably beneficial use in its existing state nor render the land capable of a reasonably beneficial use by the carrying out of any development which has been or would be permitted.

In these circumstances, the owner may serve a purchase notice on the Council. This notice will require the Council to purchase the owner's interest in the land in accordance with the provisions of Chapter I of Part VI of the Town and Country Planning Act 1990.
