In pursuance of its powers under the above-mentioned Act and Order the KIRKLEES COUNCIL (hereinafter called "The Council") as Local Planning Authority hereby permits:-

ERECTION OF DWELLING

At: 20, HOWGATE ROAD, SLAITHWAITE, HUDDERSFIELD, HD7 5AY

In accordance with the plan(s) and applications submitted to the Council on 30-May-2018, subject to the condition(s) specified hereunder:-

1. The development hereby permitted shall be begun within three years of the date of this permission.

Reason: Pursuant to the requirements of Section 91 of the Town and Country Planning Act 1990.

2. The development hereby permitted shall be carried out in complete accordance with the plans and specifications schedule listed in this decision notice, except as may be specified in the conditions attached to this permission, which shall in all cases take precedence.

Reason: For the avoidance of doubt as to what is being permitted and so as to ensure the satisfactory appearance of the development on completion, and to accord with Policies D2, BE1, BE2, BE12, T10 and T19 of the Kirklees Unitary Development Plan, Policy PLP 24 of the Kirklees Publication Draft Local Plan as well as the aims of the National Planning Policy Framework.

3. The external walls of the dwelling hereby approved that are shown to be faced in stone shall be faced in natural rumbled stone that in all respects matches that used in the construction of the dwellings on the wider development site. The dwelling shall be thereafter retained in this material.

Reason: In the interest of visual amenity and so as to sustain the significance of the Slaithwaite Conservation Area in accordance with Policies D2, BE1, BE2, and BE5 of the Kirklees Unitary Development Plan, Policies PLP 24 and PLP35 of the Kirklees Publication Draft Local Plan, as well as the aims of the National Planning Policy Framework.

4. The external roofing materials of the dwelling hereby approved shall be Sandtoft Calderdale Slate in 14 – Dark Grey. This roofing material shall be thereafter retained.

Reason: In the interest of visual amenity and so as to sustain the significance of the Slaithwaite Conservation Area in accordance with Policies D2, BE1, BE2, and BE5 of the Kirklees Unitary Development Plan, Policies PLP 24 and PLP 35 of the Kirklees Publication Draft Local Plan, as well as the aims of the National Planning Policy Framework.

5. The window frames of the dwelling hereby approved shall be UPVC in RAL 7016. The development shall be completed in accordance with this detail before each plot is occupied. Notwithstanding the provisions of the Town and Country Planning (General Permitted Development) Order 2015 as amended (or any Order revoking or re-enacting that Order with or without modification) the window frames shall thereafter be retained.

Reason: In the interest of visual amenity and so as to sustain the significance of the Slaithwaite Conservation Area in accordance with Policies D2, BE1, BE2, and BE5 of the Kirklees Unitary Development Plan, Policies PLP 24 and PLP 35 of the Kirklees Publication Draft Local Plan, as well as the aims of the National Planning Policy Framework.

6. The external front door of the dwelling hereby approved shall be Jacobean Ultimate. Notwithstanding the provisions of the Town and Country Planning (General Permitted Development) Order 2015 as amended (or any Order revoking or re-enacting that Order with or without modification) the external door shall thereafter be retained.

Reason: In the interest of visual amenity and so as to sustain the significance of the Slaithwaite Conservation Area in accordance with Policies D2, BE1, BE2, and BE5 of the Kirklees Unitary Development Plan, Policies PLP 24 and PLP 35 of the Kirklees Publication Draft Local Plan, as well as the aims of the National Planning Policy Framework.

7. The development shall not be brought into use until the area indicated to be used for parking on the approved plan(s) have been laid out with a hardened and drained surface in accordance with the Communities and Local Government; and Environment Agency's 'Guidance on the permeable surfacing of front gardens (parking areas)' published 13th May 2009 (ISBN 9781409804864) as amended or any successor guidance; Notwithstanding the provisions of the Town and Country Planning (General Permitted Development) Order 2015 as amended (or any Order revoking or re-enacting that Order) this shall be so retained, free of obstructions and available for the use(s) specified on the submitted/listed plan(s).

Reason: In the interests of amenity, traffic safety and to ensure appropriate drainage of the hard standing areas, in accordance with Policies T10 and T19 of the Kirklees Unitary Development Plan, Policies PLP 21 and PLP 22 of the Kirklees Publication Draft Local Plan as well as the aims of the National Planning Policy Framework.

NOTE: To minimise noise disturbance at nearby premises it is generally recommended that activities relating to the erection, construction, alteration, repair or maintenance of buildings, structures or roads shall not take place outside the hours of:

07.30 and 18.30 hours Mondays to Fridays
08.00 and 13.00hours , Saturdays
With no working Sundays or Public Holidays

In some cases, different site specific hours of operation may be appropriate. Under the Control of Pollution Act 1974, Section 60 Kirklees Environment and Transportation Services can control noise from construction sites by serving a notice. This notice can specify the hours during which the works may be carried out.

- This permission has been granted subject to conditions. Some of the conditions may require you to submit further details. These conditions normally contain the wording "submitted to and approved in writing by the Local Planning Authority".

- This Authority recognises the need to ensure that you are able to develop the site as effectively and flexibly as possible. However, at the same time it must ensure that development is in accordance with the terms of the planning conditions and legal agreement and the expectations of elected members and local residents set through the decision process.
- You should note the triggers for compliance with the conditions of this planning permission. This Authority is committed to processing applications to discharge conditions in a timely manner. Appeals to the Secretary of State

- If you are aggrieved by the decision of your Local Planning Authority to grant it subject to conditions, then you can appeal to the Secretary of State under section 78 of the Town and Country Planning Act 1990.
- If an enforcement notice is served relating to the same or substantially the same land and development as in your application and if you want to appeal against your Local Planning Authority's decision on your application, then you must do so within:
 - i) 28 days of the date of service of the enforcement notice, or
 - ii) within the specified period, starting on the date of this notice,whichever period expires earlier.
- If you want to appeal against your Local Planning Authority's decision then you must do so within the specified period, starting on the date of this notice.

- The “specified period” is 12 weeks where the development relates to a “minor commercial application” as defined within the Town and Country Planning (Development Management Procedure) Order 2010 (as amended), or 6 months in any other case.
- Appeals must be made using a form which you can get from the Secretary of State at Temple Quay House, 2 The Square, Temple Quay, Bristol BS1 6PN (Tel: 0303 444 5000) or online at <https://www.gov.uk/planning-inspectorate> . Further information on the Planning Appeal process can be found online at the Planning Inspectorates website <https://www.gov.uk/government/organisations/planning-inspectorate>.
- You must use the correct Planning Appeal Form when making your appeal. If requesting forms from the Planning Inspectorate, please state the type of application that the appeal relates to so they can send you the appeal form you require.
- The Secretary of State can allow a longer period for giving notice of an appeal, but he will not normally be prepared to use this power unless there are special circumstances which excuse the delay in giving notice of appeal.
- The Secretary of State need not consider an appeal if it seems to him that the Local Planning Authority could not have granted planning permission for the proposed development or could not have granted it without the conditions they imposed, having regard to the statutory requirements, to the provisions of any development order and to any directions given under a development order.
- In practice, the Secretary of State does not refuse to consider appeals solely because the Local Planning Authority based their decision on a direction given by him.

Please note, only the applicant possesses the right of appeal.

Purchase Notices

- If either the Local Planning Authority or the Secretary of State refuses permission to develop land or grants it subject to conditions, the owner may claim that he can neither put the land to a reasonably beneficial use in its existing state nor render the land capable of a reasonably beneficial use by the carrying out of any development which has been or would be permitted.

In these circumstances, the owner may serve a purchase notice on the Council. This notice will require the Council to purchase his interest in the land in accordance with the provisions of Part VI of the Town and Country Planning Act 1990.
