In accordance with the plan(s) and applications submitted to the Council on 18-Jun-2018 subject to the condition(s) specified hereunder:-

1. The development hereby permitted shall be begun within three years of the date of this permission.

Reason: Pursuant to Section 18(1) of the Planning (Listed Buildings and Conservation Areas) Act 1990, as amended by the Planning and Compulsory Purchase Act 2004.

2. The development hereby permitted shall be carried out in complete accordance with the plans and specifications schedule listed in this decision notice, except as may be specified in the conditions attached to this permission, which shall in all cases take precedence.

Reason: For the avoidance of doubt as to what is being permitted and so as to ensure the satisfactory appearance of the development on completion in order to retain the significance of the designated heritage asset and to accord with Policy BE1 of the Kirklees Unitary Development Plan, Policy PLP35 of the Publication Draft Local Plan, as well as the aims of Chapter 16 of the National Planning Policy Framework.

3. The external joinery of the hereby approved window shall have a painted finish in a colour which matches the colour of the existing windows at the property. Thereafter the external joinery of the windows shall be retained in a painted colour that matches the existing windows.

Reason: For the avoidance of doubt as to what is being permitted and in order to retain the significant of the designated heritage asset and to accord with Policy BE1 of the Kirklees Unitary Development Plan, Policy PLP35 of the Publication Draft Local Plan, as well as the aims of Chapter 16 of the National Planning Policy Framework.
