Prior notification for single storey rear extension**

I refer to your submission of details relative to the proposed extension as described below for the above property and as submitted on 17-Jul-2018.

The proposal is for erection of single storey rear extension. The extension projects 3.6m beyond the rear wall of the original dwellinghouse. The maximum height of the extension is 4m, the height of the eaves of the extension is 2.65m

It has been determined that the proposal is not acceptable and prior approval is hereby **Refused** for the following reason(s);

This proposal does not qualify for the criteria of permitted development under Class A, Part 1 of Schedule 2 of the Town and Country Planning (General Permitted Development)(England) Order 2015 (as amended) as proposed extension extends beyond the wall forming an original side elevation of the original dwellinghouse and is greater than half the width of the original dwelling and is adjoining a previous two storey enlargement to the original dwelling. This would exceed the limitations set out in sub section (j)(iii) and ja of Part 1 Class A.

The Secretary of State has power to allow a longer period for the giving of a notice of appeal but will not normally be prepared to exercise this power unless there are special circumstances which excuse the delay in giving notice of appeal.
