Prior notification for single storey rear extension**

I refer to your submission of details relative to the proposed extension as described below for the above property and as submitted on 28-Aug-2018.

The proposal is for erection of single storey rear extension. The extension projects 3.7m beyond the rear wall of the original dwellinghouse. The maximum height of the extension is 3.7m, the height of the eaves of the extension is 2.3m

Representations have been received from the owners or occupiers of adjoining premises. These have been considered by this Authority together with the effect on the amenity of adjoining properties. It has been determined that the proposal is not acceptable and prior approval is hereby **Refused** for the following reason(s);

The proposed single storey extension is considered **not** to benefit from a general planning permission under Class A of Schedule 2 of the Town and Country Planning (General Permitted Development)(England) Order 2015 (as amended) by reason of the proposed enlargement adjoining an existing enlargement to the original dwellinghouse and the combined enlargement exceeding this limitations set out in paragraphs (ja) and (j) of Class A.

Appeals to the Secretary of State

If you are aggrieved by the decision of the Local Planning Authority to refuse details of the proposed development, you may appeal to the Secretary of State under Section 78 of the Town and Country Planning Act 1990 within **twelve weeks** of the date of issue of this notice.
