PLANNING PERMISSION FOR DEVELOPMENT

In pursuance of its powers under the above-mentioned Act and Order the KIRKLEES COUNCIL (hereinafter called "The Council") as Local Planning Authority hereby permits:-

DEMOLITION OF EXISTING FRONT PORCH, GARAGE AND OUTBUILDING AND
ERECTION OF SINGLE STOREY FRONT AND TWO STOREY SIDE EXTENSION
(WITHIN A CONSERVATION)

At: 16, TOWN GATE, UPPERTHONG, HOLMFIRTH, HD9 3UX

In accordance with the plan(s), documents and application submitted to the Council on 29-Oct-2018, except as amended or specified, details of which can be found in the table below and subject to the condition(s) specified hereunder:-

1. The development hereby permitted shall be begun within three years of the date of this permission.

Reason: Pursuant to the requirements of Section 91 of the Town and Country Planning Act 1990

2. The development hereby permitted shall be carried out in complete accordance with the plans and specifications listed in this decision notice, except as may be specified in the conditions attached to this permission, which shall in all cases take precedence.

Reason: For the avoidance of doubt as to what is being permitted and so as to ensure the satisfactory appearance of the development on completion, and to accord with Policies PLP1 PLP2, PLP22, PLP24 and PLP35 of the Kirklees Publication Draft Local Plan; Policies BE1, BE2, BE5, BE13, BE14 and T19 of the Kirklees Unitary Development Plan and Chapters 12 and 16 of the National Planning Policy Framework.

3. The walls and roof of the extension hereby approved shall in all respects match those used in the construction of the existing building.

Reason: In the interests of visual amenity and to accord with and Policies PLP35 and PLP24 of the Kirklees Publication Draft Local Plan and Policies BE1, BE2, BE5 and BE13 of the Kirklees Unitary Development Plan.

4. Notwithstanding the details provided on the drawing numbered 18/389/06D, the extended parking area shall not be brought into use until it has been surfaced with a hardened and drained surface in accordance with the Communities and Local Government publication 'Guidance on the permeable surfacing of front gardens (parking areas)' published 13th May 2009 as amended or any successor guidance. The extended parking area shall thereafter be retained as such

Reason: In the interests of amenity and traffic safety and to prevent an increase in flood risk through run-off created by impermeable surfacing of the car park space. This is in accordance with Policy PLP22 of the Kirklees Publication Draft Local Plan and Policy T10 Kirklees Unitary Development Plan.

5. Notwithstanding the provisions of the Town and Country Planning (General Permitted Development) Order 2015 as amended (or any Order revoking or re-enacting that Order) no doors, windows or any other openings (apart from any expressly allowed by this permission) shall be created in the east elevation of the development hereby approved.

Reason: So as not to detract from the amenities of adjoining property by reason of loss of privacy and to accord with Policy PLP24(b) of the Kirklees Publication Draft Local Plan and Policy BE14 of the Kirklees Unitary Development Plan.

Pursuant to article 35 (2) of the Town and Country Planning (Development Management Procedure) Order 2015 and guidance in the National Planning Policy Framework, the Local Authority have, where possible, made a pre application advice service available, complied with the Kirklees Development Management Charter 2015 and otherwise actively engaged with the applicant in dealing with the application. After consultation with KC Conservation and Design, it was suggested to the agent that the originally proposed two storey front extension would not respect the character of the existing dwelling and would be contrary to PLP35 and PLP24 of the UDP. It was also suggested development of a two storey nature should continue the existing rooflines. It was also relayed to the agent that the heritage statement was written to the superseded 2012 NPPF. Amendments were received by 19/02/19 and were deemed acceptable.

Building Regulations

Appeals to the Secretary of State

- If you are aggrieved by the decision of your Local Planning Authority to grant it subject to conditions, then you can appeal to the Secretary of State under section 78 of the Town and Country Planning Act 1990.
- As this is a decision for a householder application, if you want to appeal against your Local Planning Authority's decision to impose planning conditions then you must do so within 6 months of the date of this notice.
- If an enforcement notice is served or has been served relating to the same or substantially the same land and development as in your application and if you want to appeal against the local planning authority's decision on your application, then you must do so within 28 days of the date of service of the enforcement notice.

- The Secretary of State can allow a longer period for giving notice of an appeal, but he will not normally be prepared to use this power unless there are special circumstances which excuse the delay in giving notice of appeal.

- The Secretary of State need not consider an appeal if it seems to him that the local planning authority could not have granted planning permission for the proposed development or could not have granted it without the conditions they imposed, having regard to the statutory requirements, to the provisions of any development order and to any directions given under a development order.
- In practice, the Secretary of State does not refuse to consider appeals solely because the Local Planning Authority based their decision on a direction given by him.

Please note, only the applicant possesses the right of appeal.

Purchase Notices

- If either the local planning authority or the Secretary of State refuses permission to develop land or grants it subject to conditions, the owner may claim that the owner can neither put the land to a reasonably beneficial use in its existing state nor render the land capable of a reasonably beneficial use by the carrying out of any development which has been or would be permitted.

In these circumstances, the owner may serve a purchase notice on the Council
This notice will require the Council to purchase the owner's interest in the land in accordance with the provisions of Chapter I of Part VI of the Town and Country Planning Act 1990.
