The KIRKLEES COUNCIL hereby give notice that LISTED BUILDING CONSENT has been granted for the execution of the works referred to:-

LISTED BUILDING CONSENT FOR REPLACEMENT WINDOWS, HEADS, CILLS, MULLIONS AND DOOR, INSTALLATION OF 2 NO. ROOFLIGHTS AND RE-BUILDING OF SECTION OF FRONT ELEVATION

At: 1, LISTING DRIVE, LITTLETOWN, LIVERSEDGE, WF15 6ER

In accordance with the plan(s) and applications submitted to the Council on 14-Mar-2019 subject to the condition(s) specified hereunder:-

1. The development shall be begun not later than the expiration of three years beginning with the date on which consent is granted.

Reason: Pursuant to Section 18(1) of the Planning (Listed Buildings and Conservation Areas) Act 1990, as amended by the Planning and Compulsory Purchase Act 2004.

2. The development hereby permitted shall be carried out in complete accordance with the plans and specifications schedule listed in this decision notice except as may be specified in the conditions attached to this permission, which shall in all cases take precedence.

Reason: For the avoidance of doubt as to what is being permitted and so as to ensure the satisfactory appearance of the development on completion, in the interests of the significance of the heritage asset and to accord within the National Planning Policy Framework.

3. New windows shall be timber fixed or side hung casements. Mouldings and timber sections shall be of a traditional design and profile. Opening casements and fixed lights shall be set within the window frames and shall not protrude proud of the frame (and shall have horizontal glazing bars). No works to install new windows shall take place until design and joinery details (at 1/5 scale) have been submitted to and approved in writing by the Local Planning Authority. The works shall thereafter be completed in accordance with the approved details.

Reason: So as to ensure the satisfactory appearance of the development on completion, in the interests of the significance of the heritage asset and to accord with Chapter 16 of the National Planning Policy Framework.

4. Re-pointing of masonry and the reconstructed walling on the front elevation between the ground and first floor windows shall be carried out with a mortar comprising a lime binder and well-graded sands, the mortar once set shall be of a buff colour.

Reason: So as to ensure the satisfactory appearance of the development on completion, in the interests of the significance of the heritage asset and to accord with Chapter 16 of the National Planning Policy Framework.
