A Planning Application to build a house in our garden and for our own use is currently under consideration by Kirklees Council Planning (No. 2019/90634). Before submitting the Planning Application, as part of our preparations, we had a tree survey carried out by Arbtech and gained consent from the Tree Officer for various works under Application No. 2017/93897. This consent has now expired and we are submitting this new application to renew and develop these consents as follows.

The trees involved are:

TPO 7/89

T22 Weeping ash (numbered T12 in the Arbtech Report). Because of its poor and deteriorating condition the Tree Officer recommended that this Ash

should be felled and replaced with an ornamental species of weeping habit. This consent needs renewing.

T26 Oak (numbered T8 in the Arbtech Report). The Arboriculturist rated the stem as being in "fair" condition, but noted a tear wound and cavity at a point of limb loss and described the tree as "lanky" as a result of significant damage over the years in severe weather events. The tree stands in an exposed location and remains vulnerable to further damage in high winds. Consent is therefore requested to rebalance the tree to produce a more natural form and to improve its structural integrity. The work proposed is;

Crown thinning of 20% to reduce the density of the tree and to allow more light through the canopy;

Crown reduction to achieve an overall height reduction of 5 metres and an overall balanced spread of 12 metres.

The main framework of the crown would remain intact, stress on the tree would be reduced and it would be more suited to its exposed location.

Consent was given to remove up to 8 trees of holly, laburnum and cypress as per the application. This consent need to be renewed.
