The KIRKLEES COUNCIL hereby give notice that LISTED BUILDING CONSENT has been granted for the execution of the works referred to:-

LISTED BUILDING CONSENT FOR INSTALLATION OF NEW WINDOW
OPENING, RE-PAINT WINDOWS AND DOORS (WITHIN A CONSERVATION
AREA)

At: 57, UNDERBANK OLD ROAD, HOLMFIRTH, HD9 1AS

In accordance with the plan(s) and applications submitted to the Council on 27-Apr-2020 subject to the condition(s) specified hereunder:-

1. The development shall be begun not later than the expiration of three years beginning with the date on which consent is granted.

Reason: Pursuant to Section 18(1) of the Planning (Listed Buildings and Conservation Areas) Act 1990, as amended by the Planning and Compulsory Purchase Act 2004.

2. The development hereby permitted shall be carried out in complete accordance with the plans and specifications schedule listed in this decision notice except as may be specified in the conditions attached to this permission, which shall in all cases take precedence.

Reason: For the avoidance of doubt as to what is being permitted and so as to ensure the satisfactory appearance of the development on completion, in the interests of the significance of the heritage asset and to accord with Policy LP35 of the Kirklees Local Plan and Policies within Chapter 16 of the National Planning Policy Framework.

3. The heads and cills for the new opening shall be of natural stone and shall replicate the heads and cills of the existing windows on the main two-storey house in terms of material and finish. The stone reveals shall have a fair faced finish to match the existing first floor window reveal on the south facing extension and shall not have a cut or sawn finish.

Reason: For the avoidance of doubt as to what is being permitted and so as to ensure the satisfactory appearance of the development on completion in order to retain the significance of the designated heritage asset and to accord with Policy LP35 of the Kirklees Local Plan, as well as Chapter 16 of the National Planning Policy Framework.

4. Notwithstanding the details provided, the slim double-glazed unit shall have 4mm glass with an 8mm gap.

Reason: For the avoidance of doubt as to what is being permitted and so as to ensure the satisfactory appearance of the development on completion in order to retain the significance of the designated heritage asset and to accord with Policy LP35 of the Kirklees Local Plan, as well as Chapter 16 of the National Planning Policy Framework.
