We previously had an application granted for work on trimming the crown of this particular tree (reference no 2018/TWA/93466/W). The only reason we are applying again is, not to carry out additional work, but because sprouts have re-grown from the original trunk area and if left unchecked, will result in the tree returning to it's pre approval condition.
