Beech ( 03 ) - Remove Epicormic growth, crown thin and lift

Sycamore ( 04 ) - Crown reduce and thin

Beech ( 41 ) ( located in grounds of No.3 Norfield ) - Reduce, reshape, lift crown on beech ( 41 ) which is surrounding oak ( 09 ) at lower level  
Common Hawthorne ( 10 ) - remove dead branches.  
Smooth Elm ( 11 ) - Remove epicormic growth  
Sycamore ( 12 ) - No action  
Propose to plant 4 or 5 medium growing trees e.g. Chanticleer, Cherry as shown on the plan 31 to 35 - which will not generate large tree problems going forward with the boundary at 45 The Ghyll.
