e.g. Oak (T3) - fell because of excessive shading and low amenity value. Replant with one standard ash in same position.

Sycamore (T9) - fell because of recurring damage to drains, potential damage to structure and foundations of the house, evidence that the tree may be compromised and unable to withstand extreme weather events. The house was built too close to the tree so I would not replant. Beech (T10) - fell because two houses were built too close to this tree. It's roots have caused drain damage in the past and there is a danger to both houses in windy weather from branches.
