T2 - Sycamore tree. Complete removal of the tree as it is diseased and will become a public safety hazard with a high risk of injury or property damage due the tree dying.
T3 - Horse Chesnut Tree. Remove limbs overhanging Birkby road will be removed inline with the property boundary to reduce the risk of limbs falling on the public footpath.
T4 - Lime Tree. Remove limbs overhanging Birkby road will be removed inline with the property boundary to reduce the risk of limbs falling on the public footpath.
