It is home to the Meltham Over 60's Group, Slimming World, Pilates & Zumba groups and, for many years, the venue for the annual production by the Gilbert & Sullivan Society and in later years by the Stage Company, Meltham for their annual pantomime and summer show. It is also used by Kirklees Council as the Polling Station for elections.
