ALSO PRESENCE OF DEADWOOD IN THE CROWN TO NORTH SIDE OF THE TREE MINOR AND MAJOR DEAD APPROXIMATELY 100MM UP TO 400MM. RECOMMENDED A CROWN REDUCTION ASWELL TO BRING THE TREE BACK UNDER CONTROL DUE TO ITS LOCATION.
