**The KIRKLEES COUNCIL hereby give notice that LISTED BUILDING CONSENT has been granted for the execution of the works referred to:-**

LISTED BUILDING CONSENT FOR REPLACEMENT OF EXISTING  
DEFECTIVE TIMBER WINDOWS AND DOORS WITH NEW TIMBER DOUBLE  
GLAZED WINDOWS AND TIMBER DOORS

**At:** 4, MELTHAM ROAD, LOCKWOOD, HUDDERSFIELD, HD1 3TJ

**In accordance with the plan(s) and applications submitted to the Council on 01-Apr-2021 subject to the condition(s) specified hereunder:-**

1. The development shall be begun not later than the expiration of three years beginning with the date on which consent is granted.

**Reason:** Pursuant to Section 18(1) of the Planning (Listed Buildings and Conservation Areas) Act 1990, as amended by the Planning and Compulsory Purchase Act 2004.

2. The development hereby permitted shall be carried out in complete accordance with the plans and specifications schedule listed in this decision notice except as may be specified in the conditions attached to this permission, which shall in all cases take precedence.

**Reason:** For the avoidance of doubt as to what is being permitted and so as to ensure the satisfactory appearance of the development on completion, in the interests of the significance of the heritage asset and to accord within the National Planning Policy Framework.

3. No works to install new windows and doors shall take place until joinery details at 1:5 and elevation drawings at 1:20 have been submitted to and approved in writing by the Local Planning Authority. The new windows shall be timber framed, with slim double-glazed units with a gap of no more than 8mm, and black spacer bars. All new window frames shall be set back in the reveal by 75-100mm and shall not be fitted flush with the external wall. The works shall then be carried out in complete accordance with the approved details.

**Reason:** For the avoidance of doubt as to what is being permitted and to ensure the satisfactory appearance of the development on completion to retain the significance of the designated heritage asset and to accord with Policy LP35 of the Kirklees Local Plan, as well as Chapter 16 of the National Planning Policy Framework.

4. All external joinery shall have a painted finish in accordance with a colour scheme to be submitted to and approved in writing by the Local Planning Authority before painting works commence. The works shall then be carried out in complete accordance with the approved details and shall be retained thereafter.

**Reason:** For the avoidance of doubt as to what is being permitted and to ensure the satisfactory appearance of the development on completion to retain the significance of the designated heritage asset and to accord with Policy LP35 of the Kirklees Local Plan, as well as Chapter 16 of the National Planning Policy Framework.
