I request permission to remove a large Alder Tree which has now become too large for its location. It is now growing rapidly, and is dominating the garden and creates a huge shaded area in the front lawned area. We believe it is now producing a detrimental effect to the setting of our listed farm building. It is now approximately 14m tall and this species is known to grow to around 28m. This part of the garden contains too many trees anyway as you will see in the drawing and we feel this tree is taking up a vast area in the garden when fully bloomed. The garden would benefit from less trees within it so it can be enjoyed with more space especially given the abundant other trees that will remain in the garden. The excessive shading that the tree creates means that other plants and wildlife (in the pond) receive less sunlight throughout the day.
