The KIRKLEES COUNCIL hereby give notice that LISTED BUILDING CONSENT has been granted for the execution of the works referred to:-

LISTED BUILDING CONSENT FOR INSTALLATION OF BATHROOM WINDOW
[WITHIN A CONSERVATION AREA]

At: 3, WATERFALL COTTAGES, MARSDEN, HUDDERSFIELD, HD7 6NQ

In accordance with the plan(s) and applications submitted to the Council on 12-Nov-2021 subject to the condition(s) specified hereunder:-

1. The development shall be begun not later than the expiration of three years beginning with the date on which consent is granted.

Reason: Pursuant to Section 18(1) of the Planning (Listed Buildings and Conservation Areas) Act 1990, as amended by the Planning and Compulsory Purchase Act 2004.

2. The development hereby permitted shall be carried out in complete accordance with the plans and specifications schedule listed in this decision notice except as may be specified in the conditions attached to this permission, which shall in all cases take precedence.

Reason: For the avoidance of doubt as to what is being permitted and to ensure the satisfactory appearance of the development on completion, in the interests of the significance of the heritage asset and to accord within the National Planning Policy Framework.

3. The new window shall be a side hung timber framed casement with butt hinges and a white painted finish, with mouldings and timber sections simple in design and profile with chamfered glazing beads. The opening casement shall be set flush with the frame and shall be set back in the reveal by 75-100mm and not fitted flush with the external wall. The slim double-glazed unit shall have 4mm glass with an 8mm gap with black spacer bars, and the obscured glass shall have an etched finish. Trickle vents will not be permitted.

Reason: For the avoidance of doubt as to what is being permitted and to ensure the satisfactory appearance of the development on completion in order to retain the significance of the designated heritage asset and to accord with Policy LP35 of the Kirklees Local Plan, as well as Chapter 16 of the National Planning Policy Framework.

4. The new head, cill and jambs for the proposed window shall be of natural stone with the same square section as the bathroom window at 5 Waterfall Cottages. The stonework shall match the existing first floor window of 3 Waterfall Cottages in terms of stone type, bedding and tooling.

Reason: For the avoidance of doubt as to what is being permitted and to ensure the satisfactory appearance of the development on completion in order to retain the significance of the designated heritage asset and to accord with Policy LP35 of the Kirklees Local Plan, as well as Chapter 16 of the National Planning Policy Framework.
