The removal of a 10m swathe of trees within the vicinity of the overhead line to allow for access and a safe working area for the installation of a new pole and to stop vegetation encroaching on the overhead electricity line. There is no intention to replant due to future issue that will be caused by the planting of trees underneath the line. A diagram has been attached to illustrate the area needed to replace the pole. All works will be carried out by a tree surgeon. Appropriate surveys to be undertaken by an ecologist prior to commencement. Most of the area has previously been maintained by the statutory undertaker but has become over grown recently. The removal will include 3m either side of the line and an extra 4m on the West side to allow safe machinery access up the incline without travelling under the line. An ecology survey will be undertaken before any vegetation is removed. Some cut and fill may be necessary, and this might impinge on the root protection zone of adjacent trees, such work will be kept to the absolute minimum required.

There is already some space under the line, thus the proposed work is only that required to gain access and make the new installation. More than happy to conduct a site visit to explain.
