Aged laburnum at the top of our drive on Giles Street. Overhanging the street, the minor trunk long since showing signs of previous severe damage (torn / lost major branches), is leaning and cracked. See photo's sent in accompanying email. In addition, higher up a telephone wire to neighbouring houses is snagging and causing connectivity problems about which we've had complaints.

7. Identification Of Tree(s) And Description Of Works continued ...

Detailed on site inspection / assessment by professional tree surgeon specialist contractor recommends soonest a modest reduction of the old damaged weighty branch, to allow the already vigorous new growth to progress whilst critically - importantly - reducing the weight, stress, to the lean / overhang across the street where there's not only passing traffic and pedestrians potentially at risk but parked cars.

This work is considered urgent, and if not immediate certainly should undertaken before sap starts rising pre leaf / bud i.e. well before the spring.

At the same time the 'phone line higher up in the tree crown to be freed, removing / thinning the minor snagging growth only.
