There are two large trees on the roadside boundary of the site; an oak (T5) and a sycamore (T4) - see appended site plan for tree reference. The site has been subject to the demolition of a bungalow and the building of a new house. The house build is now substantially complete and there has been no damage or ill-effect on either tree.

The sycamore has an extremely dense crown (see attached photos). This application is to seek approval for a crown thin of up to 25% to allow light and air to pass through the canopy which will reduce the risk of disease, tree root dislodgement through wind, and generally prolong the life of the tree. The works would look to be done during spring 2022 as part of the overall landscaping works on the site.

7. Identification Of Tree(s) And Description Of Works continued ...

For your information, a crown thin was discussed with a Kirklees tree officer in 2020 and it was suggested that an application was made for such works once the building works were substantially complete.

In addition, to the eastern boundary of the site there is a mature ash (T6) tree that is TPO protected but showing signs of ash die-back. There has been a number of branches that have snapped off of over this winter and the previous winter and left jagged broken branches on the tree. Approval is sought to tidy up these breaks to stop any disease getting into the tree.

Finally, on the eastern boundary to the southern end there is a mature oak (T7) that has a handful of lower hanging spindly branches no more than 15cm in diameter. Approval is sought for the removal of these handful of branches.
