Our property, 36a New North Road WF16 9DH, has two double detached garages, both location off the North (side) elevation of the house.

One of the garages is a pre-fabricated concrete construction (approx. 7m W x 6.2m L x 2.5m H at apex peak) with composite roof and double metal garage doors.

The proposed works is to move the location of this garage to an area of the garden that is unused, at the South elevation (what my be classified as the Principle elevation) of the house.

This new area is surrounded on two sides by hedges approx. 15ft high, and will not cause any visual impact to neighbours nearby.

The works would inc. the construction of a concrete base, approx. 6" high, and equal to the footprint of the garage in order to provide a solid base for garage.
