Details of the pre-application advice received

- condition 3 (materials): Under the original application we approved a natural stone wall with timber elements under a slate roof. This was set out in the application form and elevational drawings. I therefore hold the view that we cannot accept the move to reconstituted stone and concrete tiles under this discharge of condition application given what we have approved. This would need to be done through a variation of condition 2 application I believe. In addition, no details of the timber have been provided. In essence, there are two option I feel going forward. We either need
 - details of timber, natural stone and slates under this discharge of condition application; or
 - a variation of condition application in relation to the new materials you are proposing.
