Pre-application discussions between the Applicant and the case officer who dealt with the previous application (ref. 2020/62/90725/W) commenced in early 2022. As the principle of delivering 68 new homes at the application site had already been established through the site's housing allocation in the Kirklees Local Plan and the existing permission, the pre-application discussions focussed on the key design/layout changes between the approved scheme and those of the proposed scheme. These included:

- The scale of the proposed development in comparison with the approved scheme.
- The proposed breakdown of house types and sizes.
- The proposed layout; amount of landscaping and public open space; and the road arrangements.

The case officer of the previous application advised that engagement should be undertaken with local ward members and local residents.
