## Description of Proposed Works

I refer to the letter from Kirklees' Planning Enforcement Officer, Sharoz Ilyas, dated 4th October 2022 regarding my boundary fence at 32 Nettleton Avenue, WF14 9AN.

Firstly, I would like to take this opportunity to apologise for my oversight when erecting the fence; I simply hadn't realised there would be any planning considerations to take into account. It wasn't by any means an attempt to evade this process.

The fence as it is measures 1.85m high. The reason for this is that I am a joiner / kitchen fitter so my work vans / vehicles are often parked on my drive. For security, I wanted a fence which would help to keep my vans out of sight and secure as not only are the vehicles themselves valuable but also they often contain materials and my tools without which I wouldn't be able to work. I have no other premises to park my vehicles or to use as a storage facility.

When I purchased the house in 2020, there were hedges and thorn bushes on the boundary which were taller than the new fence. My neighbour's bushes (adjacent to the same road; Nettleton Road) are also taller than the fence. I have spoken to my immediate neighbours and they have assured me that they are happy with the fence and it does not cause them any concern or issues.
