In accordance with the plan(s) and applications submitted to the Council on 15-Nov-2022 subject to the condition(s) specified hereunder:-

1. The development shall be begun not later than the expiration of three years beginning with the date on which consent is granted.

Reason: Pursuant to Section 18(1) of the planning (Listed Buildings and Conservation Areas) Act 1990 as amended by the Planning and Compulsory Purchase Order 2004.

2. The development hereby permitted shall be carried out in complete accordance with the plans and specifications schedule listed in this decision notice, except as may be specified in the conditions attached to this permission, which shall in all cases take precedence.

Reason: To ensure that the proposed works preserve the character, significance and appearance of the Listed Building and to accord with the aims of Policies LP24, LP25 and LP35 of the Kirklees Local Plan and Chapters 12 and 16 of the National Planning Policy Framework.

3. All signage and associated light shall be affixed through the mortar joints only. There shall be no drill or cutting into the stonework.

Reason: To ensure that the fabric of the Listed Building is maintained and to ensure that the proposed works preserve the significance, character and appearance of the host Listed Building to accord with Policy LP35 of the Kirklees Local Plan and Government guidance contained within Chapter 16 of the National Planning Policy Framework.

NOTE: The applicant is reminded that the carrying out of unauthorised work to a listed building is an offence, punishable by a fine, imprisonment or both, as detailed in Section 9 of the Planning (Listed Buildings & Conservation Areas) Act 1990.
