The KIRKLEES COUNCIL hereby give notice that LISTED BUILDING CONSENT has been granted for the execution of the works referred to:-

LISTED BUILDING CONSENT FOR INTERNAL AND EXTERNAL
ALTERATIONS

At: MINISTERS COTTAGE, 20, POLE GATE, SCAMMONDEN, HUDDERSFIELD,
HD3 3FW

In accordance with the plan(s) and applications submitted to the Council on 02-Dec-2022 subject to the condition(s) specified hereunder:-

1. The development shall be begun within three years of the date in which this consent is granted.

Reason: Pursuant to Section 18(1) of the Planning (Listed Buildings and Conservation Areas) Act 1990, as amended by Section 51 of the Planning and Compulsory Purchase Act 2004.

2. The development hereby permitted shall be carried out in complete accordance with the plans and specifications schedule listed in this decision notice, except as may be specified in the conditions attached to this permission, which shall in all cases take precedence.

Reason: For the avoidance of doubt as to what is being permitted, to preserve the significance of the listed building and to accord with Policies LP2, LP24 and LP35 of the Kirklees Local Plan, and the policies within Chapters 2, 12 & 16 of the National Planning Policy Framework

3. Prior to their installation, a scheme detailing all new doors and windows, including bi-fold doors, shall be submitted to and approved in writing by the Local Planning Authority. The submitted scheme shall detail that all doors and windows shall be in timber, the distance they will be set into the reveals and shall be accompanied by elevation drawings at scale 1:20 and section drawings at scale 1:5. The development shall thereafter be completed with the details so approved.

Reason: In the interests of visual amenity and preserving the special character of the listed building to accord with Policies LP2, LP24 and LP35 of the Kirklees Local Plan and policies within chapters 12 and 16 of the National Planning Policy Framework.

4. New roof-lights shall be of a conservation type, fitted flush with the slates.

Reason: In the interests of visual amenity and preserving the special character of the listed building to accord with Policies LP2, LP24 and LP35 of the Kirklees Local Plan and policies within chapters 12 and 16 of the National Planning Policy Framework.

5. All coursed walling stone and quoins shall have a tooled and not sawn finish. Any replacement stone used in the alterations to the west elevation shall be replaced in a finish to match the adjacent stone.

Reason: In the interests of visual amenity and preserving the special character of the listed building to accord with Policies LP2, LP24 and LP35 of the Kirklees Local Plan and policies within chapters 12 and 16 of the National Planning Policy Framework.

Pursuant to article 35 (2) of the Town and Country Planning (Development Management Procedure) Order 2015 and guidance in the National Planning Policy Framework, the Local Authority have, where possible, made a pre-application advice service available, complied with the Kirklees Development Management Charter 2015 and otherwise actively engaged with the applicant in dealing with the application. Amendment was sought to address concerns with the initially proposed solar panels and to remove an addition to the dwelling which required planning permission.

If the applicant is aggrieved by the decision of the Local Planning Authority to refuse listed building consent for the proposed works, or to grant consent subject to conditions, he/she may, by notice served within six months of the date of issue of this notice, appeal to the Secretary of State for the Environment in accordance with Sections 20-21 of the Planning (Listed Buildings and Conservation Areas) Act 1990.
