The KIRKLEES COUNCIL hereby give notice that LISTED BUILDING CONSENT has been granted for the execution of the works referred to:-

LISTED BUILDING CONSENT FOR INSTALLATION OF ENSUITE TO MAIN
BEDROOM AND REPLACEMENT OF WINDOW WITH DOUBLE GLAZED

At: 24, FINTHORPE LANE, ALMONDBURY, HUDDERSFIELD, HD5 8TU

In accordance with the plan(s) and applications submitted to the Council on 13-Feb-2023 subject to the condition(s) specified hereunder:-

1. The development shall be begun within three years of the date in which this consent is granted.

Reason: Pursuant to Section 18(1) of the Planning (Listed Buildings and Conservation Areas) Act 1990, as amended by the Planning and Compulsory Purchase Act 2004.

2. The development hereby permitted shall be carried out in complete accordance with the plans and specifications schedule listed in this decision notice except as may be specified in the conditions attached to this permission, which shall in all cases take precedence.

Reason: To ensure the satisfactory appearance of the development on completion to retain the significance of the designated heritage asset and to accord with Policy LP35 of the Kirklees Local Plan, as well as Chapter 16 of the National Planning Policy Framework.

3. The new window shall be a timber framed casement window with a white painted finish to match the existing. The opening casement shall have a traditional window stay (friction hinges shall not be permitted) and shall be set back in the reveal as far as the existing and not fitted flush with the external wall.

Reason: To ensure the satisfactory appearance of the development on completion to retain the significance of the designated heritage asset and to accord with Policies LP1, LP2, LP24 and LP35 of the Kirklees Local Plan, as well as Chapters 2, 12 and 16 of the National Planning Policy Framework.

4. The external extractor vent for the ensuite shall be small and set directly below the eaves and adjacent to the downpipe to minimise its visual impact. The colour of the vent cover shall match the surrounding stonework as close as possible.

Reason: To ensure the satisfactory appearance of the development on completion to retain the significance of the designated heritage asset and to accord with Policies LP1, LP2, LP24 and LP35 of the Kirklees Local Plan, as well as Chapters 2, 12 and 16 of the National Planning Policy Framework

5. Notwithstanding the information submitted within the application form, consent is granted for the installation of an ensuite bathroom and replacement window and does not include boundary wall alterations or the construction of an outbuilding.

Reason: For the avoidance of doubt of what is permitted and in the interest of preserving the historic and architectural interest/setting of the heritage asset pursuant to the requirements of Section 16 of the Planning (Listed Buildings and Conservation Areas) Act 1990.
