LISTED BUILDING CONSENT FOR REPLACEMENT WINDOWS

At: 15, HILL TOP FOLD, SLAITHWAITE, HUDDERSFIELD, HD7 5EQ

In accordance with the plan(s) and applications submitted to the Council on 06-Feb-2023 subject to the condition(s) specified hereunder:-

1. The development shall be begun not later than the expiration of three years beginning with the date on which consent is granted.

Reason: Pursuant to Section 18(1) of the Planning (Listed Buildings and Conservation Areas) Act 1990, as amended by the Planning and Compulsory Purchase Act 2004.

2. The development hereby permitted shall be carried out in complete accordance with the plans and specifications schedule listed in this decision notice except as may be specified in the conditions attached to this permission, which shall in all cases take precedence.

Reason: For the avoidance of doubt as to what is being permitted and to ensure the satisfactory appearance of the development on completion to retain the significance of the designated heritage asset and to accord with Policy LP35 of the Kirklees Local Plan, as well as Chapter 16 of the National Planning Policy Framework.

3. Notwithstanding the submitted details all replacement double-glazed window units shall have a thickness of no more than 16mm.

Reason: To ensure the satisfactory appearance of the development on completion to retain the significance of the designated heritage asset and to accord with Policies LP1, LP2, LP24 and LP35 of the Kirklees Local Plan, as well as Chapters, 2, 12 and 16 of the National Planning Policy Framework.

4. Any repair works required to the stone mullions shall be undertaken using lime repair mortars.

Reason: To ensure the satisfactory appearance of the development on completion to retain the significance of the designated heritage asset and to accord with Policies LP1, LP2, LP24 and LP35 of the Kirklees Local Plan, as well as Chapters, 2, 12 and 16 of the National Planning Policy Framework.
