To conclude, on the basis of the information that I have before me, I consider that the erection of a detached dwelling on the site could be supported in principle. The proposal could however not be supported in its current form as there are concerns regarding the scale of the dwelling, the level of outdoor amenity space for future occupiers and the impact on the openings to the side of the adjacent dwelling, 2 Scopsley Green. Additional information regarding parking for the existing dwelling would also be required as part of any future planning application. Any application going forward would need to give careful consideration to the impact on visual amenity, residential amenity and highway safety and guidance should be taken from the comments made within this response.
