The approximate grid reference for the tree is SE13841223.

The tree is next to a stone wall that bounds Spider Alley. It has tilted during recent wet and windy weather and the resulting movement of its roots has caused a bulge in the wall. If it did fall once the tree is in leaf and we have windy weather then it would almost certainly cause the wall to collapse. The application is to fell the tree to prevent further damage. An early decision would be appreciated.

Over the last two years we have planted 34 fruit trees in this field and plan to plant some hedgerow trees along the wall further down the field.
